This agreement constitutes an order for wedding portraiture services, including the taking of wedding pictures as agreed to by both parties: Maryann Newman Photography, to include Maryann Newman and anyone working under the direction of Maryann Newman (referred to herein as "MNP") and \_\_\_\_\_

\_\_\_2. Model Release: Although the client will receive a flash drive of the images, unless otherwise specified, it is understood that any and all rights to images, whether printed or digital, shall remain the property of MNP and may be used for advertising, display, portfolio or any other purpose thought proper by MNP. In addition, the client may reproduce prints from the flash drive at any time for his/her own personal use. Client may not profit in any way from the MNP's work or use the images for any commercial purpose.

\_\_\_3. If MNP cannot perform this agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to illness or injury, then MNP will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re shoot and limits the photographer's liability to the amount paid under this contract.

\_\_\_4. It is understood and agreed that no other professional photographer will be allowed to photograph or take pictures at the wedding while MNP is working.

\_\_\_5. Upon signing of this agreement by both parties hereto, MNP will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.

\_\_\_7. Half of the payment is due as a deposit upon signing of this contract. The remainder of the payment is due one week prior to the wedding. Late payment fees may apply. Any fees are non-refundable in case of cancellation or date change by client.

\_\_\_9. The client is aware that the final gallery may take 4 weeks from event to posting.

\_\_\_10. Problem resolution concerning prints ordered online will be referred to the 100% satisfaction guarantee of the photofinishing lab that we use for online ordering. MNP will assist with resolution when necessary but is not responsible for any failure on the part of the photofinishing lab.
