Frequently asked questions



Electricity

How can I check what my Meter Point Administration Number is?

You can find out what your MPAN is from your local electricity distributor. If you're not sure who they are visit www.energynetworks.org/info/faqs/who-is-my-network-operator

How can I check whether our supply is single or three phase?

You can find this out by checking the number of fuse carriers installed or by referring to a qualified electrician.

What is Agreed Supply Capacity (ASC)?

This is the maximum capacity your electricity meter can carry from the network and is set by your distribution company. You can find this in your electricity infrastructure quote or by contacting your distribution company or project manager. We need this to make sure we install the correct size meter for you.

Where your ASC exceeds 110 kVA, we'll need to know who your Meter Operator (MOP) is. They'll supply you with a MOP contract for servicing and maintaining the meter. We'll liaise with your MOP to arrange the meter installation, once the supply contract is in place. If there isn't a MOP contract your meter can't be fitted. If you don't yet have a MOP, please visit www.meteroperators.org.uk/members for further information on who can supply this.

What is Whole Current (WC) and Current Transformer (CT)?

These are the different ways in which your meter measures your energy use. It's important that we get this right so we can give you an accurate quote. If you're not sure how to get them, please contact your local distribution network.

What is my CT ratio used for and how do I find out what my CT ratio is?

We use your CT Ratio to measure your consumption for certain types of supplies. If it's wrong it could affect your quote and your bills.
