## Securing Appointment Date

Payment of services will be due day of wedding. *\*No dates will be secured without a signed contract and/or paid deposit of salon rental fee.*

## Wedding Day Logistics

Hair and makeup will be done on the following criteria. The bride must communicate the importance of being on time and properly prepared.

- Anyone receiving an up-do must have CLEAN and DRY hair. Stylists will not allow extra time to blow-dry.
- If you are late for your appointment, the time allotted for each service will be shortened but the full amount of the service will be charged. The stylist will do what they can in the amount of time left for that person's appointment.

## Appointment Changes

Any changes/additions to the amount of appointments being provided after the contract is signed must be done before the date of the wedding. If any of the people that you have booked a service for do not cancel without giving 48-hour notice, you are responsible for the payment of that service.

### **Salon Reservation**

Brides have the option to reserve our entire salon to cultivate a private wedding experience.

#### General Specifications

- A private experience with no outside clients receiving services during that time.
- A 3-hour time bracket is reserved for your bridal experience (ex. 9am-12pm)
- Complimentary mimosas and a light brunch provided by our bridal team.
- In-house matching floral robes and a white robe for the bride are available for use.
- Additional room for photographers/videographers, etc.
- A private back room and restroom are available for changing.

#### Prohibitions

- Smoking is not allowed in the Goldie & Red's Salon.
- Outside alcoholic beverages are not allowed.

#### Payment

- A \$200 non-refundable deposit is required to reserve the salon for a 3-hour time bracket.
- If experience exceeds 3-hour time bracket, other clients may be in for outside services.
- If Goldie & Red's Salon is unable to provide the salon for use because of reasons beyond its control, the Goldie & Red's Salon and bride are excused from the contract, and Goldie & Red's Salon will refund \$200 reservation rent fee previously paid by the bride.

#### Other

- The bride and bridal party shall not hold neither Goldie & Red's Salon or Owner, Blair George, or any stylists accountable for any accidents or damages, including but not restricted to consequential damages, injuries, theft or acts of vandalism that occur before, during, or after the bridal experience.
