1. As used in this agreement, "Listing Broker", "we", "us" or "our" means H. Pearce Real Estate Co., Inc.; "Buyer Broker", "you" or "your" means the firm who signs this Agreement as authorized representative of Tenant, its successor, or assignee.
2. This Agreement shall commence as of _____, and shall remain in effect and in full force throughout the term of our Listing Agreement.
3. Buyer Broker represents that it is licensed in Connecticut and has a valid Buyer/Tenant Agency contract with Tenant. Buyer Broker agrees to indemnify, defend, and hold harmless Listing Broker from and against any and all claims made by any broker, agent, and/or finder (including Buyer Broker's associates) who claim to be acting by or through the Buyer Broker in connection with Buyer Broker's efforts in representing Buyer/Tenant.
4. THE COMMISSION. During the term of this Agreement, if a lease is executed by and between Landlord and Tenant, we will pay you a commission of
