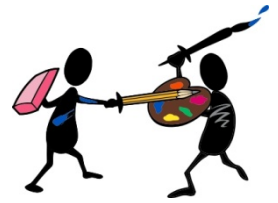




Artist Contract

The participant (Artist) agrees as follows:

Participants will bring their own supplies (paint, drawing implements, easel, canvas, etc). No advance preparation is allowed. If in doubt regarding preparation or materials, please contact Dorothy Dean at Do-All, Inc. Check-in time is at 3:00 p.m.; no earlier. The competition will begin promptly at 4:30 p.m. The competition will end promptly at 7:30 p.m. Any participant working outside these parameters will be disqualified. Artists may compete as individual or in teams. All artist work must be authentic; including images.

No hazardous, bio-hazardous, toxic or destructive materials or implements are permitted. No spraying or throwing of paint will be allowed. Airbrushing is allowed; must be noted on contract. The participant(s) agree that Do-All, Inc. shall have complete, absolute and final authority to disallow any materials, implements, to determine and interpret the rules herein, and to disqualify any participant.

Participation is limited to sixty-five (65) participants or teams. To enter you must complete this contract and paying a \$25 enter fee. The registration fee only includes entrance for 1 artist; additional fee of \$15 for each team member.

Prizes and Judging

Art Competition will be juried by a panel. The criteria for judging will be originality, technical skill/ability, aesthetic beauty, visual elements, quality and degree of difficulty. Winners will be determined by the juried panel. Entrance fee for the general public shall be \$25 per person, \$20 prior to April 15, 2016. Do-All, Inc. reserves the right to manage any situation that arises, such as a conflict, alleged rule violation or tie, in the manner it chooses. Winners will be announced immediately upon tabulation and cash prizes awarded to winners. Prizes are: One \$500 for first place, one \$250 for second place, and one \$100 for third and 4th & 5th place will receive \$50. Youth categories will be in judged separately. Categories include: Preschool – 2nd grade (\$50 Prize), 3rd -5th grade (\$50 Prize), 6th -8th (\$50 Prize) and 9th -12th (\$100 Prize). **Children competing in the youth category that receives assistance from anyone will be disqualified from receiving prize winnings.** People's Choice Award will receive \$100.

Auction

Participants must agree to allow their completed work to be a part of the auctions. Participants will receive 50% of the auction price. The remaining 50% will benefit Do-Art Studio & Gallery a Program at Do-All, Inc. Payment will be mailed within 30 business days after the event. The prize award winner's artwork will be auctioned off during a live auction; other artwork will be part of a silent auction with minimum bid of \$20.00. No other artwork shall be sold during the event.

Payment

Entry fee must be paid at the time this contract is signed. No reimbursement shall be given by Do-All, Inc. for no-show or cancels. Participants must sign contract and submit to Do-All, Inc. to qualify to participate. Participants will check-in and initial contract at the event on Saturday, April 23, 2016 at **Graff Chevrolet** by 4:00 p.m.

Waiver and Indemnification

Participants agree to hold harmless and indemnify Do-All, Inc. for any claims resulting from participant's act omission, or resulting from this ArtClash 2016 event. I hereby grant Do-All, Inc. permission to interview me and/or to use my likeness in photograph(s) and my artwork in photograph (s)/video in any and all of its publications and in any and all other media, whether now known or hereafter existing, controlled by Do-All, Inc, in perpetuity, and for other use by Do-All, Inc.
