



SURVEILLANCE/RETAINER AGREEMENT

No services shall be rendered by Shadow Trackers, Inc. to the client until the retainer fee of \$300.00 has been paid in full and a Retainer Agreement has been signed. Any balance of monies owed by the Client shall be paid in full upon the receipt of the final investigation report. ***If at any time during investigation the monetary amount for service exceeds the amount of the retainer, investigation shall stop until further funds are replenished.***

If it becomes necessary to institute litigation to enforce the terms of this agreement, such litigation shall take place in Ada County, ID. _____ (initial)

Interest shall accrue on any unpaid monies owed by client at the rate of ten percent (10%) per annum or the maximum amount recoverable by law, whichever is less.
