## Jr. & High Program Procedures:

### Jr & High School Programs:

- Teen programs are for students in 6<sup>th</sup>– 12<sup>th</sup> grades (some events may be labeled **High School only**). Children must meet the minimum grade requirement by the first date of the program.
- If you sign-up and realize you can't come, please call as soon as possible. The sooner we know you won't be coming the quicker we can let another know they can attend.
- Registration is required for most programs (except for events labeled "drop-in") because there is a limited space due to our occupancy capacity and it allows us to provide the best programs possible.
- Registration is on a first-come first-served basis. At the discretion of the Program Coordinator, we may decide to add a second time for the same program, depending on the demand of the program.
- Parent permission slips must be signed **yearly** for all children attending 'after hours' and 'Teen' events. The permission slip will remain valid until the following school year.
- **For after hour events, attendees must be picked up within 10 minutes of the scheduled end time.** If parents are late, efforts will be made to try to contact the parents. If the parent cannot be reached and the child has been approved to stay in the library by themselves, then the staff will assume they can wait outside by themselves for parents to arrive.
- Complaints or suggestions about programs should be discussed with the Program Coordinator.

### Rules during Events and Programs:

- The rules are simple: Respect yourself, others, and the library.
- No swearing or hurtful slang, running in the library, rough-housing or inappropriate touching such as **P**ublic **D**isplays of **A**ffection. Use general considerate behavior towards others at the programs.
- Once the doors close, teens cannot leave without a parent picking them up. If parent has alternate form of transportation (i.e. child walking home or going home with a friend) this needs to be told to the Program Coordinator in advance. Once a teen leaves the building, they are no longer allowed back into the building.
- Rules for the specific program will be discussed at the start of the program. If any rules are broken, children will get two warnings. On the third warning parents will be called, unless the infraction is deemed great enough to warrant an immediate phone call.
