The parents hereby declare that they know the General Terms and conditions of the Krümel Babysitterservice GbR (available at <http://www.kruemel-babysitter.de/agbs/>) and agree with these conditions.

§ 1 Start and extent of the child care

1) Name (and age) of each child to whom care services are to be provided

2) The babysitter is obliged to care for the child at the agreed period of care.

§ 2 Cancellation of the agreed child care

1) In case of illness or other unavailability of the babysitter the Krümel Babysitterservice GbR attempts to look for alternative babysitters.

2) If the babysitter is sick or indisposed, he/she must contact the parents and the Krümel Babysitterservice GbR immediately, so that they may provide an alternative child care.



§ 3 Payment

- 2) The child care will be invoiced monthly. The invoice is based on the timesheet, which must be signed by the parents at the end of the agreed child care time.
- 4) The parents have to pay the invoice within 7 days.
- 5) Complaints regarding the invoice must be made in writing to Krümel Babysitterservice GbR within 5 days following the date of the invoice, otherwise the invoice will be deemed to have been accepted.

§ 5 Diseases or medical specifics of the child

- 1) The parents are required to inform the babysitter about allergies and diseases or other health specialties of the child. The following diseases are known:

- 2) Infectious diseases of the child or a family member must be communicated to the babysitter and the Krümel Babysitterservice GbR immediately. The babysitter decides about a possible child care assignment based on the circumstances of each case.

- 3) When the child gets ill during the care period the babysitter may require that at least one parent takes over the care of the sick child itself. Basically, the babysitter has to contact the parents before consulting a doctor. In



the event of the unavailability of the parents the babysitter is entitled to consult a doctor and/or request emergency medical services.

5) The necessary documents and objects (e.g. vaccination card, passport emergency, first aid kit) are to be made available to the babysitter.

§ 6 Liability

The parents shall not be entitled to claim damages, including damages based on any pre-contractual obligations or on tort, unless arising by

1. willful misconduct or gross negligence of the babysitter or any of its agents or servants; or
2. negligent violation of a material contractual duty by the babysitter or any of its agents or servants; or
3. negligence of the babysitter or any of its agents and servants in respect of babysitter's duties in a way causing injury to life, body or health; or
4. any compulsory statutory liability of the babysitter or the babysitter's agents or servants.

§ 7 Duty of disclosure

1) The parents are obligated to provide all essential information for the child care.
