#### GENERAL MEAL PLAN FACTS:

- If time conflicts arise, a student may request a sack lunch from Buddy's Cafeteria.
- Meals do not carry over from semester to semester.
- Food service provided during Winter Intercession requires an additional contract.
- Meal Plans cannot be changed after the second Friday of the semester.
- Meal charges under this contract are refundable at 50% of the remaining value of the base (cost minus Flex Dollars).

#### FLEX DOLLAR FACTS:

- The Flex Dollar amount is deposited once per semester, and is non-refundable.
- Flex Dollars enable customers to make dollar for dollar purchases at all campus food locations.
- Flex Dollars remaining at the end of the Fall semester will roll to the Spring semester providing another Meal Plan with Flex is in place at the start of the Spring semester. Flex Dollars remaining at the end of the Spring semester are forfeited.
- Flex Plans can be purchased/renewed multiple times a semester.

I agree that all of the terms, conditions, and provisions contained in this document, including the reverse, are part of this contract and that I am fully bound to abide by such terms, conditions, and provisions. Also, as a condition of this contract, I agree to comply with all rules, regulations and policies; the University of Central Oklahoma Code of Student Conduct, the Residence Life Student Handbook, and other posted and/or distributed rules and regulations incorporated herein by reference. ## ELIGIBILITY

This contract is valid for UCO students. Residential students who reside in a hall that requires a meal plan as part of their UCO Housing & Residential Engagement contract may purchase additional meal plans with this contract.

## CONTRACT TERMS

**Legally Binding:** This document becomes a legally binding contract when accepted by UCO. This normally occurs upon receipt of a signed contract.

**Contract Alterations or Omissions:** Alterations or omissions from this contract are not permitted. You cannot be released from the conditions of the contract, except in a writing signed by both parties, you and UCO.

**Insurance Responsibilities & Damages:** Although precautions are taken to maintain a safe University, UCO does not carry personal property insurance. The student and his/her parent or legal guardian should carry appropriate insurance to cover such losses of personal property.

**Rates and Payments:** The amounts you are to pay are as outlined in this contract. Rates are subject to change by UCO at the direction of the Board of the Regional University System of Oklahoma (RUSO). Purchase price of Meals per Week plans initially contracted after the second Friday of classes of a semester will be pro-rated based on the value of the base (cost minus Flex) at the time of purchase. Flex attributable to the plan will not be pro-rated – patron will be charged for and will receive the full value of Flex dollars associated with the plan. The purchase price of Meals per Semester plans and Flex Dollar Plans are not pro-rated.

**Promo Period:** A special sale price will be applied to Meals Per Semester and Flex Dollar Plans from July 15, 2019 to August 31, 2019.

**Cancellation:** This contract may be cancelled at any time. No refunds will be given for meal plan cancellations during the last 2 weeks of the semester. Current semester meal plans will be refunded at 50% of the remaining value of the base (plan cost minus flex dollars.) No unused Flex Dollars will be refunded. Future semester meal plans will be refunded at 100% (includes Flex) – Plans must be cancelled prior to the meal plan start date.

**Withdrawal:** Meal plans for anyone who withdraws from the university will be cancelled, and penalties will be applied per the above cancellation clause.

## FINANCIAL RESPONSIBILITY

Failure to satisfy the financial obligations accrued under this contract may result in denial of permission to enroll and/or issuance of transcripts pursuant to UCO rules and regulations governing the imposition of these sanctions. Refunds will be governed by the Terms and Conditions of the contract as specified under the Cancellation section of these terms.

**Financial Aid:** The University reserves the right to automatically apply financial aid funds to your contract balance. If the financial aid applied to your meal charges is insufficient to cover your total contract, it is your responsibility to ensure that your account is current and paid in full. Failure of the University to automatically apply available financial aid does not relieve you of your financial responsibility.

## PAYMENT

Payment for meal plans are due in accordance with UCO Bursar payment deadlines.
