

Terms and Agreement

1. Little Tots International Family Daycare (hereafter referred to as LTI) is a privately-owned family daycare established in 2016, which expanded into a daycare in 2018.
2. LTI provides full-time, part-time and short-term services to families in the Helsinki region. LTI also offers Private Nanny At Home service within Helsinki, Espoo and Vantaa regions.
3. Private Nanny At Home service is available daily from 8am until 10pm. Private Nanny At Home service may be done at the home of the family or in an agreed location.
4. Private Nanny At Home service mainly focuses on the care for your child. Doing some light household chores can be discussed with the private nanny, as long as there is only one (1) child being looked after.
5. Regular babysitting, such as an 18-hour/week schedule, will be considered as Private Nanny At Home and may be eligible for Kela subsidy.
6. The family arranges the schedule with the private nanny personally and will be charged a monthly fee instead of the hourly rate.
7. The invoice is sent via email and payment is due on the last day of the month.
8. In case the invoice is not paid two (2) weeks after the due date, another invoice will be reissued with a 5€ reminder fee as well as the valid interest of 8%.
9. If our private nanny do not or cannot do the agreed hours due to their own personal reasons, LTI will deduct the amount from the monthly fee accordingly.
10. However, if the family has scheduled it so that there will be less hours per week, the full monthly fee will still be charged.
11. Moreover, if our private nanny do less than the agreed hours due to the family's own reasons, the full monthly fee will still be charged.
12. In case of accidents, the private nanny will report the situation to the child's parent/ guardian and the child's parent/ guardian will bring the child to the nearest health care center or to Lastenkliniikka, when necessary. The child/ren are insured by LähiTapiola during the Private Nanny At Home hours with LTI.
13. LTI requests the family to give their feedback on our Private Nanny At Home service and the private nanny by writing a review on our Facebook page, www.facebook.com/littletotsintl.
14. LTI reserves the right to amend any of the terms and agreement stated in this contract.
