WEDDING DAY LOGISTICS

On the wedding day, the hair will be done following a schedule. The bride must communicate the importance of being on time and properly prepared. Every person getting their hair done in an updo, half-up style, or curls must have their hair already blown dry. The stylist will not allow time for this. If such a case arises, the stylist will charge extra to blow dry (if time permits) or the service will be forfeited and the charge will still apply.

The Bride must confirm and commit to the number of services stated above. Charges will include all people stated above. Last minute additions, inside 30 days prior to event, must be confirmed and will only be accommodated if possible.

It is suggested that all persons having hair dress wear a button up shirt, to avoid pulling collar over hair while changing . It is also preferred to dress hair that has been washed the day before (not day of) and allowed to dry with natural texture.

The stylist needs a designated space to set up when on location. The bride is responsible for clearing an area before the stylist arrives. The stylist will need a work area with a chair near an outlet in a no walk-through traffic area. Good light and a mirror is a plus! If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply. The hair stylist will not be held liable for any injuries that should arise while on location.

FEE DETAILS

Trial run:

A trial run is recommended for the bride. This needs to be booked at least 30 days prior to the wedding day. Based on availability, the appointment should be about 1 month before the wedding. The trial will take place in the salon. There is a fee of \$85 per 60 minutes. This is non-refundable should you cancel the wedding date for any reason.

Wedding Day:

The bride agrees to pay the total fee of services in full on the wedding date. The total amount due is based on the wedding day services requested. The total fee is due to the hair stylist as described, regardless of internal arrangements between the bride and the others receiving services. The payment can be cash, check, or credit.

In Salon: (reservation only/business hours):

Bride \$85

Updo, curls/waves, or half up style \$85 /person

Blow dry & style \$45/person additional \$20 for hot tool

Children (up to 10yrs.) \$35-55/person

Make Up \$65 (False lashes an additional \$10)

*There may be an additional charge for off hours booking

On Location:

Bride \$120

Updo, curls/waves, or half up styles \$120/person

Blow dry & style \$75/person additional \$25 for hot tool

Children (up to 10yrs) \$45-65/person

Make Up \$75 (False lashes an additional \$10)

Travel Fees are included in pricing for travel up to 30 miles. An additional \$50 charge applies to locations 20 miles beyond up to 50 miles and another \$50 charge for up to 70 miles. Beyond 80 miles Bride is responsible for hotel accommodations for hair service team.

The bride will be responsible for parking fees the stylist must pay at the wedding location.

This contract is due 30 days prior to the wedding date or the date will be released and made available on a first come, first served basis. One stylist will be guaranteed on the wedding date. She will be available for up to 4 people, including the bride, requesting services with the minimum being \$350. If there are 6 or more people requesting services another stylist must be hired on to help. And a minimum charge of \$700 will apply.

Upon receipt of this contract, we will total the amount that is due on the wedding date as well as provide a detailed schedule to the bride. Should the stylist have a personal emergency that prevents her from performing services as agreed, all efforts will be made so that a replacement stylist will be present to perform the contracted services. Should an emergency occur so last minute that no stylist can be made available, all fees will be refunded.
