relationship between them for reasons known to them; and

**WHEREAS**, it is the desire of the parties to amicably adjust, compromise and settle all  
property rights and all rights in, to or against each others' property or estate, including property  
heretofore or hereafter acquired by either party and to settle all disputes existing between them,  
including any and all claims for maintenance and/or support, equitable distribution, fees, costs  
and all other relief provided for under the Pennsylvania Domestic Relations Code, as amended, or  
any other laws in any other jurisdiction or any other proceeding which has been or may be  
instituted by either party in any court in the Commonwealth of Pennsylvania or any other  
jurisdiction; and

**WHEREAS**, the parties hereto have exercised good faith and have made a full and fair  
disclosure to each other regarding their assets, liabilities, income, expenses, and any and all  
financial and property matters pertaining to this Final Marriage Settlement Agreement; and

**WHEREAS**, Wife has carefully read and understands all of the terms, conditions and provisions and the legal effect of this Final Marriage Settlement Agreement, and believes that this Agreement is fair, just, adequate and reasonable in all respects and accordingly freely and voluntarily accepts all of the terms, conditions and provisions set forth herein; and

**WHEREAS**, Husband has carefully read and understands all of the terms, conditions and provisions and the legal effect of this Final Marriage Settlement Agreement, and believes that this Agreement is fair, just, adequate and reasonable in all respects and accordingly freely and voluntarily accepts all of the terms, conditions and provisions set forth herein; and

**NOW THEREFORE**, in consideration of the mutual covenants herein contained and the parties hereto intending to be legally bound, agree as follows:

## **I. DEBT**
