The CLIENT agrees to maintain contact with LES LAROCHE, P.L. and cooperate fully with the law firm in this representation.

It is expressly understood and acknowledged by all parties that ATTORNEY will work toward the most favorable outcome in all cases but makes no promises or guarantees of a specific outcome.
