DHB Net Banking User Profiles

All authorizers (persons with Authorizer or Single Authorizer profile) will be designated on DHB Net Banking in accordance with their mandates of the Company as presented to Demir-Halk Bank (Nederland) N.V.. Non-signatories to the account(s) shall not be set-up as authorizer(s) until the board resolution authorizing such person(s) to act in that capacity is submitted to Demir-Halk Bank (Nederland) N.V..

There are four (4) types of profiles that can be assigned to DHB Net Banking users; View, Initiator, Authorizer, Single Authorizer.

The holders of all profiles, except the View profile, can access to DHB Payment Accounts of the Company in order to create a payment transaction in line with the below mentioned capacity of that profile. It is not possible to assign more than one profile to the same user. However, by default, Initiator, Authorizer and Single Authorizer profiles have also View profile.

View Profile: holder can view transactions of all accounts of the Company, download statements of all accounts of the Company, cannot input any transaction or authorize any transaction.

Initiator Profile: has the option of entering payments within their transaction limits or cancel their own transactions before the transaction is approved. The holder of the initiator profile can view all accounts of the Company and download statements of all accounts of the Company.

Authorizer Profile: has the option of entering, cancelling and authorizing a transaction, can view all accounts of the Company and download statements of all accounts of the Company. The holder of this profile can cancel his own or other users' transactions before the transaction is approved however the holder of this profile cannot approve his own transactions. If the holder of authorizer profile inputs a transaction then a different user with authorizer profile can authorize a transaction. Transactions authorized by the holder of authorizer profile are debited to the related account of the Company.

Single Authorizer Profile: has the option of entering, modifying, cancelling and authorizing a transaction, can view all accounts of the Company and download statements of all accounts of the Company. The holder of this profile can modify, cancel, or authorize his own transactions. The transactions entered and approved by the holder of authorizer profile are debited to the related account of the Company. The user with this type of role can also open 'DHB MaxiSpaar' or 'Solidextra' time deposit accounts.

▶ Declaration of Agreement
