

# DLC MEMBER AGREEMENT FORM



## Directions

Toastmasters International requires that any member appointed to the District Leadership Committee (DLC), agrees to and signs the DLC Member Agreement Form. Please submit your signed form to the chair of the DLC. Completed forms will then be submitted to the District Director.

## Eligibility

To be a DLC member, I agree to all eligibility requirements identified below:

- I am an active paid member.
- I am not currently serving as the District Director, Program Quality Director, or Club Growth Director.
- I am not an International officer or director candidate, member of the Board of Directors, or Region Advisor.
- I have not served on the DLC in the previous Toastmasters' year.
- I take personal responsibility for my conduct, individually and as a leader of Toastmasters International.
- I agree to abide by the principles contained in "A Toastmaster's Promise."
- I will fully comply with the governing documents of Toastmasters International and my club.
- I will refrain from any form of discrimination, harassment, derogatory, illegal, or unethical conduct, and I understand that if I engage in such conduct, I may be responsible to reimburse Toastmasters International, my club or other clubs, or other individuals involved with Toastmasters, for any damages, losses, or costs resulting from my conduct.
- I will abide by the timeline provided in Article XI of the District Administrative Bylaws.
- I will identify and seek qualified candidates for each elected position.
- I will commit to meet on a regular basis to conduct candidate assessments and to complete the selection process.
- I understand that Toastmasters programs are conducted by volunteers who cannot be effectively screened or supervised by Toastmasters International or its clubs.
- I will always conduct myself in a professional manner and adhere to core values of Toastmasters International.
- I understand that disagreements can and will occur. Therefore, I promise to focus on the issue at hand and not on the individual.
- I release and discharge Toastmasters International, its clubs, governing bodies, and representatives from any liability for the intentional or negligent acts or omissions of any member or officer of my club or other clubs, or any officer of Toastmasters International.
- By signing this agreement, I acknowledge that I have a full understanding of the duties and responsibilities prescribed in the Governing Documents.
