FOR COUNTY VOTERS' PAMPHLET

INSTRUCTIONS FOR SUBMITTING STATEMENT OF ENDORSEMENT (WCED-VP6)

General Instructions

If the name of a person or organization is used in a 'Candidate Statement' or 'Measure Argument' as supporting or endorsing the 'Candidate Statement' or 'Measure Argument',

YOU MUST EITHER:

1. Use the name and title, if used, of the person or the name of the organization with a quotation made by the person or by an authorized person on behalf of the organization. The **exact** quotation **must have been disseminated to the public prior to its' inclusion** in the 'Candidate Statement' and/or 'Measure Argument' and the **quotation must be identified** in the 'Candidate Statement' and/or 'Measure Argument' by its source and date of dissemination/publication. Examples for identifying the source (such as the name of the newspaper/website in which it appeared) of a quote are:

James Joyce, *The Oregonian*, 1/22/90

Paul Smith, *Mayor Smith's Website*, www.vote4PSmith.org, March 2011

OR file a 'Statement of Endorsement' (WCED-VP6).

Statement of Endorsement' (WCED-VP6)

1. The 'Statement of Endorsement for County Voters' Pamphlet' (WCED-VP6) form should be filed with the 'Candidate Statement' (WCED-VP4) or 'Measure Argument' (WCED-VP1) it relates and must be received by the County Elections Division no later than 5:00 p.m. on the filing deadline day for WCED-VP4 or WCED-VP1. **A postmark does not count.** A faxed WCED-VP6 is acceptable. Any forms received after 5:00 p.m. on the deadline day will be rejected.
2. If a WCED-VP6 is not received, the person or organization whose name is mentioned will be edited from the WCED-VP4 or WCED-VP1.
3. If the information contained in the 'Endorsement Voters' Pamphlet Box' **does not match** what is printed in the WCED-VP4 or WCED-VP1, these forms **will be edited to match the information contained in the 'Endorsement Voters' Pamphlet Box' as submitted on the WCED-VP6 form.**
 - A. File a 'Statement of Endorsement for County Voters' Pamphlet' (WCED-VP6) signed by the person, or by an authorized person on behalf of an organization, stating that the person consents to the use of the name and title, if used, of the person and/or name of the organization as provided in the submitted WCED-VP4 or WCED-VP1. The information in WCED-VP4 or WCED-VP1 should be an **exact** replica of what is provided in the WCED-VP6 'Endorsement Voters' Pamphlet Box'.
 - B. If a person or an authorized person on behalf of an organization wants to issue an endorsement statement that has **not been disseminated publicly prior to its' inclusion**, they must include this endorsement statement, the name of the person, and title, if used, and/or name of the organization making the statement within the 'Endorsement Voters' Pamphlet Box'. The information in WCED-VP4 or WCED-VP1 should be an **exact** replica of what is provided in the WCED-VP6 'Endorsement Voters' Pamphlet Box'.

Ex. 1 –Endorsement submitted on WCED-VP4: "I, Former Mayor George Washington, endorse Abraham Lincoln for mayor."

Endorsement in WCED-VP6 'Endorsement Voters' Pamphlet Box'; signed by George Washington.

"I. Former Mavor Georae Washinton. endorse Abraham Lincoln for mavor."

Ex. 2 – Organizational endorsement submitted on WCED-VP1: "Clark Council supports Measure ## as it benefits the community."

Organizational endorsement in WCED-VP6 'Endorsement Voters' Pamphlet Box'. **Note:** Each Councilor must sign and submit a WCED-VP6 form.
