If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.**

**\*This list may not include prices for certain items you select, such as cemetery charges or crematory services, flowers, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. ## ALTERNATIVE SERVICES:

The following charges for direct burial and direct cremation do not include additional items of service, merchandise, facility use and livery that the customer may wish to select.

### Federal Trade Commission (FTC) Disclosure

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory, necessary authorizations; and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a cardboard, fiberboard containers or an unfinished wood box.

### New York State Disclosure

**If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.**

Direct Cremation includes the local transfer of remains to the funeral home, the services of the Funeral Director and staff, securing of necessary authorizations, local transportation by livery to the crematory, an alternative container for cremation and the return of the cremated remains to the funeral home.

In all, we offer two basic package services for direct cremations:

The first package includes Direct Cremation with a cremation container supplied by the purchaser. (All such containers must meet any state or crematory requirements). \$ 2,245.00

The second package includes Direct cremation with Cardboard Alternative Container:

**The direct cremation prices do not include the crematory charge.**

## DIRECT BURIAL / IMMEDIATE BURIAL:

### Federal Trade Commission (FTC) Disclosure

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

The second package includes the services as described above but with the alternative container supplied by the purchaser. \$ 2,345.00

**Federal Trade Commission (FTC) Disclosure**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**New York State Disclosure**

**In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.**
