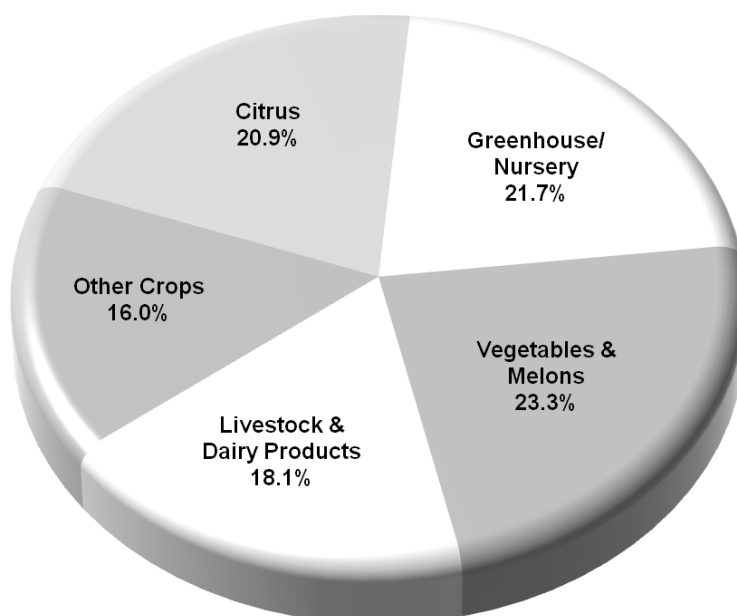

Florida Cash Receipts

The Economic Research Service reports that cash receipts from Florida agricultural products in 2011 totaled to \$8.26 billion. This is an increase of 5.4 percent from 2010.

Citrus: Citrus cash receipts from grapefruit, oranges, tangelos, and tangerines totaled \$1.73 billion, compared to \$1.54 billion a year earlier. Cash receipts for grapefruit at \$178.2 million were down 11.3 percent, oranges at \$1.48 billion were up 16.3 percent, tangelos at \$12.8 million were up 60 percent, and tangerines at \$62.2 million were up 1.0 percent.

Vegetables and Melons: The 2011 cash receipts for Vegetables and Melons totaled \$1.93 billion, were down fractionally from the previous year. Fresh tomatoes at \$564.7 million decreased 9.0 percent from the previous year. Fresh green peppers at \$247.7 million were down 16.2 percent.

Cotton: Cotton cash receipts including lint and cotton seed, at \$83.2 million, were up 25.8 percent.

Peanuts: The 2011 cash receipts for peanuts totaled \$129.2 million, up 30.1 percent.

Greenhouse and Nursery: Cash receipts for greenhouse and nursery products totaled \$1.79 billion, up 1.7 percent.

Livestock: The 2011 cash receipts for Livestock and Livestock Products at \$1.50 billion were up 11.1 percent. Meat Animals receipts at \$490.7 million were down 2.2 percent, dairy products at \$545.4 million were up 24.2 percent. Poultry and Eggs totaled \$362.8 million, up 18.7 percent.
