Coraschatten Puppy Sales Contract

Coraschatten is dedicated to the improvement of the Deutsch Langhaar (DL) in accordance with the breeding standards of the Deutsch Langhaar-Gruppe Nordamerika (DL-GNA). The intent of this contract is to assure that the dogs produced from this kennel will receive appropriate care and will be protected from indiscriminate breeding, so that the outstanding qualities of upland and waterfowl hunting ability, temperament, and health are enhanced. It is to be recognized that this DL puppy represents many years of careful breeding and is considered to be of extreme value both to the seller and to the buyer. Seller guarantees that all shots are current and deworming accomplished as necessary. This puppy has a microchip in his/her shoulders and a tattoo on his/her right ear with corresponding Deutsch Langhaar Verband (DLV) registration number. The buyer agrees to provide all necessary veterinary services in the future and shall maintain the dog in a contained area with adequate shelter.

The buyer agrees to pay a nonrefundable deposit of \$500.00 to reserve the right to purchase a puppy from this litter. This will be a deposit towards the purchase price of the puppy. The balance to be paid prior to the time of possession is \$_____ for a total purchase price of \$1,800.00. The puppy must be picked up at the seller's house between 8 and 9 weeks of age. Buyers that cannot pick up their puppy by 9 weeks of age will be charged an additional boarding fee. The buyer is responsible for arranging all necessary puppy transport. This puppy and registration papers applying to this puppy will remain the property of the seller until final payment is made. Deposits are only refundable if no puppy is available from this litter. Buyer will maintain the best possible standards of canine health, cleanliness and veterinary care, including mental health such as contact with people, and exposure to birds and the outside world.

A full refund will be given for any puppy found ill by veterinary exam during the first 72 hours. Coraschatten DLs are also guaranteed to be functionally free of hereditary genetic diseases for up to twenty-six (26) months of age. If your puppy develops a life-threatening or life-altering illness (a condition that impedes the dog's ability to hunt) that is found to be hereditary in nature (as diagnosed by your veterinarian) before the age of twenty-six (26) months, the seller will do one of three things: (1) replace the puppy from another mutually agreed to comparable breeding when such a breeding becomes available, (2) refund the full purchase price of the puppy, or (3) provide a partial refund. In order to receive the replacement puppy or the full purchase price refund, the original puppy must be returned. If the buyer chooses to keep the puppy, a partial refund will be made. The buyer must provide written documentation from his/her veterinarian that the puppy has been spayed/neutered to receive a new puppy or full/partial refund. This guarantee must be in the original owner's name, and is non-transferable to new owners if the dog is sold.

The buyer strongly believes that EVERY Coraschatten DL should be tested in a VJP (Spring Puppy Test; www.dl-gna.org/about-dls/performance-testing/) and have his/her hips evaluated. Therefore, the seller will refund \$500.00 of the original \$1,800.00 purchase price after the seller submits a copy of the Formblatt 3 (VJP Scoresheet) AND the completed Deutsch Langhaar Verband HD Röntgenuntersuchung (Hip Evaluation Form) to the seller. Buyer agrees this dog may only be bred in accordance with the breeding regulations set in place by the DL-GNA (www.dl-gna.org/breeding/deutsch-langhaar-breeding/). Each Coraschatten DL will be sold with Limited Registration in the North American Versatile Hunting Dog Association (NAVHDA). Once your puppy has been certified for breeding by the DL-GNA, the seller will revoke the limited registration with NAVHDA.

Buyer agrees that, should they ever decide to part with this dog, the seller must be notified immediately and given first option to take the dog back. The seller will take the dog back or assist in finding a suitable home for it. The buyer is responsible for all transport costs to return the dog to the seller. AT NO TIME will this Coraschatten DL be surrendered to a shelter or humane society. The seller will always assist in placing this dog.

The buyer agrees that, should they not meet any and all terms of this agreement, the seller may repossess this animal, after giving 10 days written notice. The buyer agrees to pay any lawyer fees, court costs, traveling and shipping expenses, and other miscellaneous expenses incurred by the seller in repossessing this animal.

Buyer agrees that any further transfers of this Coraschatten DL are bound by this agreement. Seller certifies that all statements made in this contract are true and correct to the best of their knowledge.
