

<b>AMENDMENT n° [ 1] to the JEC WORLD 2021 EXHIBITOR's CONTRACT</b>

This amendment (the "**Amendment**") is made on \_\_\_\_\_ (date) 2021 (the "**Effective Date**"),

**BETWEEN THE UNDERSIGNED**

- (1) **JEC**, a simplified joint stock corporation ("*société par actions simplifiée*"), with a share capital of € 308,000, organized and existing under the laws of France, the registered office of which is at 251 Bd Pereire -75017 PARIS (France), registered at the companies and trade registry of Paris, under the registration and identification number 410 352 611 represented by the President Mr. Eric Pierrejean, duly empowered for the purpose hereof,

Hereinafter referred to as "**JEC**" or the « **Organizer** »,

**and**

Hereinafter referred to as the « **Exhibitor** »,

parties to the JEC WORLD 2021 (leading international composite show) Exhibitor's contract (the "**Contract**").


**WHEREAS**

- (A) Pursuant to the Contract, the JEC WORLD 2021 edition (the "**Exhibition**") was initially programmed to take place in Paris (France) on March 09 -11 2021.
- (B) Due to the COVID-19 pandemic and further to the survey conducted by JEC from October 26, through November 02, 2020, a large majority of the Exhibitors voted in favor of a rescheduling of the Exhibition on June 01-03, 2021.
- (C) In light of the on-going uncertainty linked to the current COVID-19 health crisis and spread of new variants of the virus, JEC conducted a new survey from February 17<sup>th</sup> 2021 through February 24<sup>th</sup> 2021, whereby a large majority of the Exhibitors (88%) voted in favor of a new rescheduling of the Exhibition.
- (D) In light of the above, and the absolute necessity due to COVID-19 health crisis, JEC organization has made the decision to changes dates and reschedule the Exhibition as per article 1.2 of the Contract Terms and Conditions.

**NOW, THEREFORE,** in consideration of above, the Contract is amended as follows:

1. The Exhibition is rescheduled to be held in Paris (same venue) from March 8<sup>th</sup> 2022 through March 10<sup>th</sup> 2022 (opening days).
2. Financial terms for the participation to the Exhibition remain unchanged.
3. Booth locations and booth type of the Exhibitor remain unchanged
4. Except as set forth in this Amendment, the Contract is unaffected and shall continue in full force and effect in accordance with its terms. All terms and conditions of the Contract which are not modified by this Amendment shall remain fully effective and entirely applicable.
5. Capitalized terms used herein and not otherwise defined herein have the meanings assigned to such terms in the Agreement.
6. This Amendment is to read in full conjunction with the Contract you executed and wherever in conflict between the Contract and this Amendment, the latter shall prevail in substance and for consequences.
