Whereas, Owner desires to sell the above referenced aircraft ("Aircraft") and appoints Mid Island Air Service/ NY JET ("MIAS") as exclusive marketing agent, the parties agree as follows:

1. **Worldwide Marketing Campaign:** MIAS shall conduct a worldwide marketing campaign for the Aircraft. Qualified prospects will be identified through MIAS's data systems and the daily contact of its marketing professionals. MIAS will prepare and distribute marketing materials for the Aircraft, including Internet web pages, broadcast email and fax campaigns, photographs, technical specifications and various magazine advertisements. MIAS will absorb all costs incurred for the foregoing marketing efforts.
2. **Extranet Access & Consultation:** MIAS shall provide Owner private access to relevant market data via its Client Extranet or facsimile and at Owner's request, will render advice on any area of MIAS's expertise. Owner will be forwarded all offers, along with MIAS's recommendation, for consideration.
3. **Aircraft Data:** Owner shall provide the following: (a) current specifications and equipment lists; (b) current inspection schedule status; (c) interior and exterior photographs; (d) Aircraft access w/ prior notice.
4. **Representations & Authority:** MIAS is hereby selected to exclusively manage the sale of the Aircraft and is directed to represent the Aircraft's condition at time of sale as follows: (a) airworthy; (b) systems functioning normally; (c) current on maintenance; (d) free and clear of liens and encumbrances; and, (e) with all available logbooks, manuals and records. As Owner's agent, MIAS shall have no authority to accept or bind Owner to any sale. Acceptance of any offer shall be in Owner's sole discretion
