Capgemini to provide global maintenance and development services for Kemira IT infrastructure

Paris, Helsinki (January 15, 2007) – Kemira Oyj, Finnish chemicals group, and Capgemini Finland Oy (Capgemini), part of Capgemini Group, one of the world's leaders in consulting, technology and outsourcing services, sign a major outsourcing agreement.
