

# VIP Pet Care Boarding Agreement

- 1) This is a Contract between VIP Pet Care (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner") for services for (hereinafter called "Pet").
- 2) Payment is expected in full for any and all services provided for pet at the time of discharge. Owner agrees to pay the rate for boarding in effect on the date Pet is checked into the Kennel as posted on the Schedule of Services and Fees.
- 3) Owner agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by Kennel for the Pet during the time it is in the Kennel's care. Kennel shall attempt to contact Owner before incurring such services as may be required by Pet's health and/or behavior/ if no contact is made it will be in the kennel's discretion where the pet is taken. Fees will also be applied for VIP staff to take a pet to any veterinarian office.
- 4) By signing this Contract and leaving the Pet with the Kennel, Owner certifies to the accuracy of all information given about said Pet to the best of their knowledge.
- 5) Kennel agrees to exercise due diligence and reasonable care, and to keep the premises sanitary. It is expressly agreed by Owner and Kennel that the Kennel staff will handle and care for all pets without liability on the kennel's part for any sort of loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other pet(s) or property by said pet(s), or from other unavoidable causes, due diligence and care having been exercised. The Owner further agrees to be solely responsible for any and all acts or behavior of said Pet while it is in the care of the Kennel.
- 6) Pets boarding at VIP are required to be vaccinated for Kennel Cough. Your pet should receive this vaccination at least 1 month prior to boarding for maximum protection; otherwise the pet is not fully protected. The vaccine should be given every 6 months for best protection. This vaccination is only a recommendation and not a required core vaccination. If the owner chooses not to have their pet vaccinated against this virus it is at their own risk. Initial of Owner or Agent \_\_\_\_\_(See vaccination waiver)
- 7) Owner specifically represents to Kennel that the Pet has not been exposed to rabies or distemper within a thirty-day period prior to boarding.
- 8) If the Pet becomes ill or if the Pet's behavior is endangering itself humans, or other animals, the Kennel, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of the Pet first, however in the event of an extreme emergency the well being of the Pet comes first and appropriate action will be taken. Medication will be administered as necessary under the direction of a veterinarian. The undersigned Owner hereby gives the veterinarian and their assistant's complete authority to treat Pet in whatever manner deemed necessary by the veterinarian on duty. The Owner will be responsible for all veterinary charges upon release of the Pet.
- 9) All pets are checked for external parasites (fleas/ticks/lice/papillomas virus) upon entry to the facility. If any external parasites are found, they will be treated accordingly and the Owner is responsible for those expenses.
- 10) If the client does not pick up or call within 3 days after the agreed upon pick up date, a phone call or letter will be sent regarding the animals abandonment. Should the animal not be removed within the specified time, I, the client hereby relinquish all claims to my animal and ownership of the pet will be assumed by the Kennel. The animal in question will become property of VIP Pet Care.
- 11) VIP Pet Care reserves the right to refuse any pet.
- 12) Owner agrees that their pet may be videotaped, photographed, and or recorded. The Kennel shall be the exclusive owner of the results and all proceeds of such tapings, photography, and recordings with the rights, throughout the world, and unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The Owner further agrees that the pet may be used in any and all media and in the promotion, advertising, sale, publicizing, and exploitation of VIP Pet Care.
- 13) By signing this agreement the Owner indicates that he or she has read and accepted all policies listed in this agreement.
- 14) This contract will be valid each time the pet is boarding with VIP Pet Care, and is only required to be signed once and applies to the current daycare/boarding visit along with all future visits.
