

Dealership Agreement

1. **Dealer Services.** The company hereby appoints the dealer to perform the following services in accordance with the terms and conditions set forth in this agreement: The dealer will consult with the officers and employees of the company concerning matters relating to the management and organization of the company, their financial policies, the terms and conditions of appointment, and generally any matter arising out of the business affairs of the company.

2. **Terms of Agreement.** This agreement will begin for **One Year** Either party may cancel this agreement on thirty (30) days notice to the other party in writing, by certified mail or personal delivery.

3. **Time Devoted by Dealer.** It is anticipated the dealer will spend **6 Days/Week - 9 Hours a day** in fulfilling its obligations under this contract. The particular amount of time may vary from day to day or week to week.

4. **Place Where Services Will Be Rendered.** The dealer will perform most services in accordance with this contract at their own Place. In addition the consultant will perform services on the telephone and at such other places as designated by the company to perform these services in accordance with this agreement.

5. **Payment to Company.** The dealer will do a **cash and carry** process on all the products purchased from the company. Credit system is not followed by the company. The dealer needs to make a direct deposit to the company by bank account transaction only; no other mean of transaction will be accepted. Usually 80% of the total amount is to be paid in advance to confirm the order. Balance amount should pay at the time of receiving 100% Product.

6. **Independent Dealer.** Both the company and the dealer agree that will act as an independent contractor in the performance of its duties under this contract. Accordingly, the dealer shall be responsible for payment of all taxes including All State and local taxes arising out of the dealer's activities in accordance with this contract, including by way of illustration but not limitation, National and State income tax and any other taxes or business license fee as required.

7. **Confidential Information.** The consultant agrees that any information received by the consultant during any furtherance of the consultant's obligations in accordance with this contract, which concerns the personal, financial or other affairs of the company will be treated by the consultant in full confidence and will not be revealed to any other persons, firms or organizations.

8. **Deposit.** The dealer has to pay Rs.10,000.00 (Ten Thousand Only)Amount to deposits
