



Sponsorship Agreement:

ICC Relief Limited (**ICC Relief**) supports child protection standards and we request that you read the following Sponsorship Agreement carefully. These regulations are required to ensure the safety of the children on the ICC Relief child sponsorship program and also you as a sponsor.

Thank you for supporting ICC Relief with your agreement to join our child sponsorship program. As part of your agreement to sponsor a child, we provide the following information relating to the ICC Relief program. This explains ICC Relief commitment to child safety and ensures all children in our care are provided with equal support and benefits.

Section 1 Sponsorship Terms

1. The terms and conditions of this agreement between ICC Relief Limited (ABN 39 634 536 137) and you govern your sponsorship and/or donation (“Contribution”) to ICC Relief Limited.
2. ICC Relief agrees to debit your nominated bank account or credit card account on the agreed given day of each month (“Debit Date”), or next working day for the amount of Contribution nominated by you, If the payment fails, we will re-attempt to debit your account.
3. You agree that:
 - a) you will confirm with your financial institution that your nominated account can accept direct debits;
 - b) there will be sufficient funds in the nominated bank account or credit card account to cover the amount of the Contribution on the Debit Date;
 - c) you will advise ICC Relief if the nominated bank account or credit card account is transferred or closed.
4. You may make the following changes regarding your Contribution by written notice to ICC Relief or by verbally advising our staff on ---- at least 14 working days prior to the next Debit Date:
 - b) defer a particular debit and arrange to catch it up at an agreed later date
 - c) cancel all debits and terminate this agreement with ICC Relief.

5. If you believe that a debit to your nominated bank account or credit card account has been made without your authorisation (“Unauthorised Debit”) you
6. Agree to advise ICC Relief by written notice or verbally advise our staff on ---- immediately upon becoming aware of the Unauthorised Debit.
7. ICC Relief agrees to refund the amount of the Unauthorised Debit to you where we cannot show that you authorised the Debit.
8. You agree that ICC Relief has the right to terminate this agreement by written notice to you in its absolute discretion without giving any reasons.
9. By you entering into this agreement, we will obtain personal information about you, as that term is defined by the Privacy Act 1988 (Cth) (“Personal Information”). By signing this agreement, you agree that ICC Relief may collect your Personal Information to process your Contribution and you consent to ICC Relief transferring relevant parts of your Personal Information overseas to its suppliers and to its affiliated offices, to the extent reasonably required by ICC Relief.
10. The governing law of this agreement shall be the law of Western Australia and the parties agree to submit to the exclusive jurisdiction of the courts of that state.

Section 2 Sponsored Child

We encourage you to send gifts, cards and letters to your sponsored child organised by us. However, please do not send any money or religious material. Money can be sent through ICC Relief child sponsorship. We are unable to provide direct email communication with a sponsored child so please send items by e-mail to ahmad.foyouz@iran-children-charity.org Please include your name and the name of your sponsored child.

You are welcome to visit your sponsored child if you are planning a trip to Iran. However, the meeting must be arranged by the ICC Relief through our partners in Iran. Please try to provide at least two weeks’ notice of your visit so that we can ensure you will have an opportunity to meet with your child. Requests can be sent to ahmad.foyouz@iran-children-charity.org.

Neither ICC Relief or any partner will be held liable in the event of injury or death related to a sponsor visiting a child.

For safety and security reasons, the sponsor is not allowed to take a child for any outings. Meetings will take place at the child’s home, school or the ICC Relief partner’s office.

As a sponsor, you are usually welcome to take photographs while visiting a child, however any photos taken are to be for personal use only and not shared via the internet or other public media. You must gain permission from the child's parent or guardian before taking photos.

Please be aware that the total funds required to support your sponsored child may be sourced from one or more sponsors.

If your sponsored child leaves the ICC Relief child sponsorship program, you will be notified and invited to accept another child.

The child information that you receive is accurate according to our records at the time your request was processed. The family information provided may vary from year to year as our partners receive new information regarding your sponsor child.

By sponsoring a child, you are accepting the conditions of this agreement.
