2018 RESOLUTION AWARD OF CONTRACT

2018 RESOLUTION - AWARD OF CONTRACT - 2018-2019 SNOW PLOWING & REMOVAL CONTRACT FOR THE BLOOMFIELD PARKING UTILITY

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on October 30, 2018 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Snow Plowing and Removal Services for the Bloomfield Parking Utility; and

WHEREAS, three bids were received from the following bidders and were subsequently referred to the Township Engineer for review:

WHEREAS, the following is noted when comparing the two bids:

- Stanziale Construction, LLC provides more available equipment in six of the nine contract items than American Asphalt & Milling Services, LLC. American Asphalt Milling Services, LLC provides more available equipment in one of the contract items.
- Stanziale Construction, LLC provides lower unit prices for four of the nine contract items. American Asphalt Milling Services, LLC provides lower prices in three of the nine contract items.
- A comparison of unit prices based on a single unit (price per unit) of the various contract items indicates that Stanziale Construction, LLC provides a lower overall cost.

WHEREAS, the unit prices provided by Stanziale Construction in their proposal are as follows:

SNOW PLOWING

A-1	Single Axle Truck (minimum 26,000 GVWR)	2 trucks at \$200 per truck
A-2	Tandem axle trucks (minimum 26,000 GVWR)	2 trucks at \$200 per truck
A-3	Single axle trucks (minimum 12,000 GVWR)	5 trucks at \$200 per truck
A-4	Calcium Chloride ice melt materials	1 unit at \$1.75 per unit
A-5	Sodium Chloride ice melt materials	1 unit at \$0.25 per unit

SNOW REMOVAL & HAULING

B-1	20 cu. yd. roll offs truck for hauling	5 trucks at \$200 per truck
B-2	60 cu. yd. roll offs truck for hauling	4 trucks at \$200 per truck
B-3	Tandem axle trucks	4 trucks at \$200 per truck
B-4	Tri-axle trucks	4 trucks at \$245 per truck


WHEREAS, it is the recommendation of the Director of the Bloomfield Department of Public Works and Parks as well as the Township Engineer that the contract for Snow Plowing and Removal be awarded to Stanziale Construction, LLC, PO Box 2597, Bloomfield, NJ 07003 based upon the unit prices provided in their proposal; and

WHEREAS, the Director of Finance has certified that funds are available within the parking utility account number T-13-56-013-SR1.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above services with Stanziale Construction, LLC, PO Box 2597, Bloomfield, NJ 07003 for the unit prices provided in their proposal.
