2. Approval of Minutes

3. Resignation

a. Talia T. moved to accept Lisa L. Olson's Resignation as Park Drive Site Representative. Kristin M 2nd the motion. Motion passed.

4. Staff Updates

a. Wait List remains steady.

- b. Monthly Inspections continue on the Third Wednesday of each Month. Notices of Non-Compliance will be issued as needed. City has provided a load of compost and a load of mulch for gardeners to access. Additional work will include thinning of trees at Park Drive.
- c. Permit renewals will be initiated in the beginning of June. Fee increases are on the City Council Agenda for Mid-May.

- b. Would like to initiate monthly columns. Ken Hansen may have these.
- c. Completed 4th Grow LA Victory Garden Class at Ishihara this past month. New gardeners have been taking these classes which have proved beneficial. Two MG's who helped with the class are interested in starting up a Food Preservation Program. Working with SMC on growing Native Milkweed. TW requested to have someone start working on a Beautification Design for the Parking Lot at Main St. Kristin expressed interest in initiating.
- d. Talia T. moved to change name of Increasing Garden Opportunities to Urban Agriculture Expansion. Cris G. 2nd. Motion passed. Meetings have started and initial focus will be on vacant properties.
- e. Need to finalize the Appeals Process for gardeners who have received Forfeiture Notices.

8. Task Force on the Environment Update

Climate Corps are working on developing a proposal to support the Urban Ag Incentive Zone. They have also initiated a garden near Eddie's Liquor on 20th St.
