Description of Services

This proposal reflects services including 40 vehicle hours of patrols per week. Vehicle patrols will generally take place between the hours of Random hours (descretion of client). Patrol Vehicle will be a high profile SUV with Mobile Platform for online reporting. Officers will be in uniform. Signal 88 Security will continue to provide NFC tokens at locations throughout the town. Client may choose locations of tokens and desired report from each.

Services include monitoring property for a variety of site specific property violations such as:

Loitering
Vandalism
Theft
Suspicious activity etc.

Signal 88 Security will conduct random door and business checks each night as well as provide assistance to the citizens of Fairfax. Communication will be on going between the client and Signal 88 representatives. Proposal includes attendance at council meetings or as requested at no additional charge.

Communication with the property will be through online reporting accessible through our 88Edge website as well as the franchise owner or designated personnel. Officers will be well trained and dressed in Signal 88 uniforms with 3M Reflective lettering. Alarm calls will be included at no additional charge up to the number of tours per night. Residents will be provided the Signal 88 dispatch number to contact our central command center where a "live" person (supervisor on duty) will be available for assistance.
