

## Proposal to change Web hosting away from Wesh

### The current situation

Currently Melbourn Parish Council owns 3 domains:

The website is hosted by Wesh with a cost of £25 per month for 1.75Gb of space.

The emails are looked after by the Parish Council IT service provider, Lucid, who charge £3.00+VAT per month for each of the Clerk, AssistantClerk and RFO emails.

Lucid support currently costs £52.50 per month for their “covered” service (includes unlimited access to support) plus a further £18 for backups service and anti-virus software.

All prices are ex-VAT

### Immediate requirements for MPC

1. Reduce costs of web hosting by moving away from Wesh.
2. Obtain a cost effective method of assigning an official MPC email address to each councillor and officer (and removing/disabling it when a person is no longer a councillor or officer).

### Further requirements for MPC

1. Consolidate the domains so that we are using only one domain for email and web pages.
2. Re-vamp the website to tidy it up and make it more user friendly.
3. Investigate a cheaper solution for IT support.
4. Move to a .gov.uk domain.

### Recommendations

Based upon the information gathered (see appendix) and searching online reviews of web hosting providers, I recommend that, in the first instance, we retain our current domains, but switch to 1and1.com to host both web pages and emails.

Their “Plus” package gives unlimited webspace (with unlimited traffic) and unlimited email addresses – each with a 2Gb mailbox size. It would also allow us to operate two domains – melbournpc.co.uk and melbournparishcouncil.co.uk - so that the new website could be built up under the melbournpc domain and then switched into use when ready. The melbournparishcouncil domain could then be pointed at the melbournpc one.

The management of email addresses will devolve to the Clerk instead of Lucid, but should be straight forward to manage. **Outstanding action: Is 2Gb sufficient for mail of the officers?**

I would suggest that a small working party is set up to consider the requirements for the design of the web page and our existing service provider is consulted over them prior to the website revamp.

## **.gov.uk Domain**

All local government organisations who wish to have a web presence must set up on the (restricted) .gov.uk domain. The restrictions in place give a measure of reassurance that the public is dealing with an official body when connecting to a .gov.uk domain. There is a significantly higher cost for owning a .gov.uk domain (between £45 and £120 per year based on research shown below).

For the moment, any local government organisation that has an existing web presence based on a .co.uk or similar domain is permitted to keep and maintain it without changing it to a .gov.uk domain. The author suspects that in the future the requirement to be on a .gov.uk domain will become mandatory, but MPC does not have to concern itself with this for the moment.

## **Data Collected**

Note that all domain registration costs below relate to .gov.uk domains. Typical costs for .co.uk or .org.uk etc are circa £10pa as MPC is currently paying.

Companies selected at random from the official government list of domain registrars who handle .gov.uk domains. Many of those on the list are either no longer trading or don't do registrations of any sort any more.
