1. Introduction:

Department of Tourism (hereinafter referred to as “DoT” or “Authority” or “Department”) aims to develop Odisha as one of most preferred tourist destinations in India. Concerted efforts are being put in place to position the state prominently in the domestic and international tourist source markets. One of the initiatives being undertaken by Dept of Tourism in this background is organizing Eco Retreat – a seasonal glamorous camping event in which will be organized in multiple destinations of the state.

Some of the project sites chosen for the event are sandy beaches and riverbanks, where vehicle and people movement are difficult. To address this DoT intends to procure Heavy Duty Access and Ground Protection Mats with mat connectors (“Product” or “work”) which will be laid at selected site locations that enables pedestrian and logistics movement in the sandy area by ensuring least ecological damage to the beach.

In this background, proposals are invited from manufacturers / authorized dealers for Supply of Heavy Duty Access and Ground Protection Mats to DoT for using them on sandy beaches to create temporary facility for movement of vehicles and pedestrians. The Product should provide proper traction to both vehicles and pedestrians. It should enable a smooth vehicle and pedestrian movement on sandy beach area.

2. Scope of Work:

2.1 The Bidder (hereinafter referred to as “Bidder” or “Supplier” or “Manufacturer”) would be required to supply 1140 (Nos.) of Heavy Duty Access and Ground Protection Mats to DoT at the below address:

2.2 DoT reserves the right to increase or decrease the quantity of Product as per the requirement. Payment shall be made only on the actual quantity of delivery of Product.

2.3 Technical Specifications for Supply of Heavy Duty Access and Ground Protection Mats:

2.3.1 The Product will be used on sandy beaches to create temporary facility for movement of vehicles and pedestrians. The Product should provide proper traction to both vehicles and pedestrians. It should enable a smooth vehicle

and pedestrian movement on sandy beach area. Accordingly, the Product shall be compression molded HDPE (Highdensity polyethylene) mat, which can take contour of the ground and offer the requisite flexibility.

2.3.2 The Product will be used for temporary access and ground protection in the sandy beach area. Accordingly, the mat should be able to perform in the harshest environment, in all type of ground condition, including a few listed below:

- Rainey and wet regions
- Hot and humid environments
- Sandy beaches

2.3.3 The Product should be able to handle and support a vehicle load of up to 80 Tonnes. In other words, the load bearing capacity should be 80 Tonnes per mat.

2.3.4 The Product should be easy to install and tough & durable.

2.3.5 Overall Dimension of a single mat: 2410 mm (Length) X 1200 mm (Breadth) X 12 mm (Thickness).

2.3.6 Usable surface area of a single mat: 2.89 square meter.

2.3.7 Approximate weight of a single mat: 36 Kg (Approximate Density: 1.04 g/cm³)

2.3.8 Fire Rating: UL94HB

2.3.9 The Product shall have the property of no liquid absorption and be chemically inert. It should be easy to clean and decontaminate.

2.3.10 The product should be safe in terms of preventing any slips, trips or falls.

2.4 Timeline for delivery of the Product: 1 month from the date of issue of Letter of Award.

2.5 The Supplier shall submit manufacturer's certificate certifying the quality of the product. The supplier shall guarantee the endurance / quality / performance of the Product and submit the manufacturer's warranty for a period of one (1) year from the date of delivery against all manufacturing defects. Any manufacturing defects detected during the above said warranty period shall be rectified free of cost by the supplier.

3. Eligibility Criteria

For bidders to become eligible to participate in this bidding process, the following basic eligibility conditions must be met.

- 3.1 The bidder should be an entity incorporated / registered under the Companies Act 2013 or a Limited Liability Partnership registered under the LLP Act 2008 or a Sole Proprietorship. The bidder must submit a proof of Registration of the legal entity (Certificate of Incorporation, GST registration certificate)
- 3.2 The bidder must be a manufacturer / authorized dealer for supply of Heavy Duty Access and Ground Protection mats.
 - 3.2.1 Bidder must submit at least one case of their successful supply of Heavy Duty Access and Ground Protection mats to Govt. / Public Sector / other reputed firms. Documentary proof (Work Order / Purchase Order / Payment receipt) must be submitted to substantiate the claim.

4. Bid Evaluation Criteria:

- 4.1 Financial bids of only eligible bidders i.e., bidders meeting all the requirements under clause 3 of this document, will be considered for evaluation.
- 4.2 Financial Bid should be quoted in the prescribed format given in Annexure-III.
- 4.3 The bidder quoting lowest amount i.e., L1 bidder will be the preferred bidder.
- 4.4 The second and third ranked Bidder shall be kept in reserve and may be invited for negotiations in case the first ranked bidder withdraws or fails to comply with the requirements specified in the RFP document.

5. Bid Processing Fee

The proposal shall be accompanied with non-refundable bid processing fee of INR 20,000 (INR Twenty Thousand Only) in the form of Demand Draft in favor of "Director Tourism" payable at Bhubaneswar. A bid without the requisite bid processing fee shall be treated as non-responsive and rejected.

6. Earnest Money Deposit (EMD)

The Proposal shall be accompanied with Earnest Money Deposit (EMD) of INR 50,000 (INR Fifty Thousand Only) in the form of Demand Draft / Bank Guarantee issued by Scheduled Commercial Bank in favor of "Director Tourism" payable / encashable at Bhubaneswar. Proposals without the requisite EMD shall be treated as non-responsive and rejected. Unsuccessful bidder's EMD will be discharged / returned within 30 days from the date of execution of the contract between DoT and the preferred bidder. No interest will be paid on EMD. The EMD of the successful bidder shall be returned immediately upon execution of the contract with DoT. The EMD may be forfeited in the following cases:

- a) If a bidder withdraws their bid during the Bid validity period

- b) In case of a successful bidder, if the bidder fails to sign the contract within the specified time

7. Terms of payment:

- 7.1 The Supplier will receive 90% of the payment from DoT within 15 days from the date of delivery of the Product.
- 7.2 The balance amount will be paid only after completion of the warranty period of the product as mentioned under Clause 2 of this RFP.
- 7.3 The Supplier shall forfeit the balance amount in case:
 - 7.3.1 Supplier fails to rectify the manufacturing defects as required under Clause 2.5 of this RFP.

8. Bid Validity:

The Bid shall remain valid for a period of 90 days from the last date of submission of bid.

9. Disputes:

All legal disputes are subject to the jurisdiction of Courts in Bhubaneswar only.

10. Right to Reject any or all Bids:

- 10.1 Notwithstanding anything contained in this invitation document, DOT reserves the right to accept or reject any Proposal and to annul this selection Process and reject all proposals, at any time during the bidding process without any liability or any obligation for such acceptance rejection or annulment, and without assigning any reasons thereof and is not under any obligation to accept the lowest offer.
- 10.2 DOT reserves the right to reject any Proposal if:
 - a) at any time, a material misrepresentation is made or uncovered, or
 - b) the Bidder does not submit sufficient information as being asked for

10.3 DoT reserves the right to execute partly / fully the work through other agency / firm.

11. Submission of Bid:

- 11.1 The Technical Bid (Part A) and Financial Bid (Part B) must be inserted in separate sealed envelopes, along with bidder's name and address in the left-hand bottom corner of the envelope and super scribed in the following manner.

13. Consortium

Bidders are not allowed to form consortium for participating in the bid.

14. Performance Security

- 14.1 DoT shall issue a Letter of Award (LoA) to the preferred bidder post completion of the evaluation process. Within 7 days of issuance of LoA, the preferred bidder would be required to submit Performance Security and enter into contract with DoT. The Performance Security shall be for an amount equivalent to 2% of the contract value in the form of an irrevocable and unconditional Bank Guarantee from a Scheduled Commercial Bank. The Bank Guarantee shall be drawn in favor of 'Director Tourism'.
- 14.2 The performance security shall be retained till the delivery of the Product as per the requirements of this RFP.
- 14.3 The performance security shall be forfeited at the sole discretion of DoT in case of any failure by the Supplier to deliver the Product as per the requirements of this RFP.
