Request for Proposals

Sidewalk Construction Services

I. Background Information

Situated along the Hudson River approximately 35 miles from Albany, the Village of Schuylerville is a desirable residential community for families and individuals working in the Capital District and surrounding areas. An excellent school system and new businesses contribute to the overall quality of life in the village.

The Village is seeking estimates for sidewalk construction and/or replacement in Fall 2018. The construction area is along the southern portion of Spring Street (Route 29) from Green Street to Pearl Street. Reconstruction of sidewalks is to be done on both sides of Pearl Street from Saratoga Street to Ferry Street.

II. Scope of Work, Specifications and Requirements of Bidders

- A. Construction of sidewalks along Spring Street from Green Street to Pearl Street. Green St. to Oak Lane is 156 ft., and Oak Lane to Pearl Street is 171 ft. Estimated 327 linear ft.
- B. Reconstruction of sidewalks on both sides of Pearl Street from Saratoga Street to Ferry Street. Estimated 710 linear ft. per side or 1420 ft. total.

Work must be engineered to last up to 10 years.

Proper permitting must be obtained before construction begins.

All work must meet guidelines for municipal sidewalks, which states that it must be at least 4 inches deep on compacted surface and at least 4 feet wide.

All materials must be from an approved NYSDOT source. Quantities may vary due to variations in materials. Plant batch tickets shall be provided upon request by the Village Building Inspector. If approved equal mixes are being proposed, prior approval shall be obtained from the Village Building Inspector. Submittals for approved equal mixes shall be provided with test results from at least three (3) previous jobs.

Concrete shall have a minimum compressive strength of 4000 P.S.I. at 28 days and shall conform to the NYSDOT 2002 Specifications as listed in Section 501-2 for Class "A" mix (or approved equal)

All slip-form concrete curbing shall conform to the requirements for a Class J concrete mixture (or approved equal)

Pedestrian walkways must also meet ADA Title II requirements, including the construction of curb ramps or other sloped areas at intersection of roadways.

Any clarifications, revisions, or modifications thereto shall only be made subject to approval of the Village Building Inspector.

NYS prevailing wage rules apply.

Qualified Service-Disabled Veteran-Owned SDVOB) and Minority/Woman Owned Business Enterprises (M/WOB) are encouraged to bid.

III. Form of Proposal

Respondents must provide a brief description of the firm, emphasizing areas of expertise or focus of practice. Please include a list of recent projects that emphasize familiarity with municipal sidewalk construction.

Respondents must also describe the type of materials used and the proposed construction process. Estimates should be broken down into engineering (if applicable), excavation, construction, materials costs, and construction supervision/inspection.

IV. Criteria for Bid Award

Bids will be awarded according to the methodology prescribed by Section 103 of the General Municipal Law. Selection of the Contractor will be on a non-discriminatory basis without regard to race, color, national origin, gender, sexual orientation, or age.

VI. Detailed Requirements / Specifications

To facilitate the comparison of Bids for the financial component of the overall scoring, fees and expenses must be presented on the enclosed Cost Worksheet (attached Addendum A) and sealed separately for subsequent review. Bids that do not include a fully completed Cost Worksheet, or that alter the form, may be disqualified.

Bids shall remain in effect for a minimum of 90 days following the proposal due date.

The Village reserves the right to:

- reject any bid, request for assignment, renewal or extension for an entity that appears on the Prohibited Entities List prior to the award, assignment, renewal or extension of a contract, and to pursue a responsibility review with respect to any entity that is awarded a contract and appears on the Prohibited Entities list after contract award;
- request clarification of bid details following submission of bids;
- select all or part of the bid
- withdraw this Request for Bids without awarding a contract.

VIII. Additional Requirements

- A. Non-Collusive Bidding: All bids must be accompanied by the attached Non-Collusive Bidding Certification (Addendum B, Attached).
- B. Procurement Lobbying Law: All bids must be accompanied by the attached Affirmation of Understanding and Agreement (Addendum C, attached)
- C. Equal Employment Opportunity Policy (EEO): All responses must include a statement that the Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, national origin, sex, age, disability, or marital status, will undertake or continue existing programs of affirmative action to ensure that minority group members are afforded equal employment opportunities without discrimination, and shall make and document its conscientious and active efforts to employ and utilize minority group members and women in its work force if awarded all or part of this contract.
- D. Insurance: Contractor shall maintain and provide the following insurance: Commercial General Liability insurance of \$1 million per occurrence and \$2 million in the aggregate; Commercial Automobile Liability with a limit of \$1 million for both bodily injury and property damage; Excess/Umbrella Liability of \$5 million; Errors and Omission insurance as necessary with a limit of \$1 million and evidence of Workers Compensation/Employers' Liability insurance providing statutory NYS coverage. Policies must add the Village of Schuylerville, State of New York, and Village of Schuylerville DPW as additionally insured.

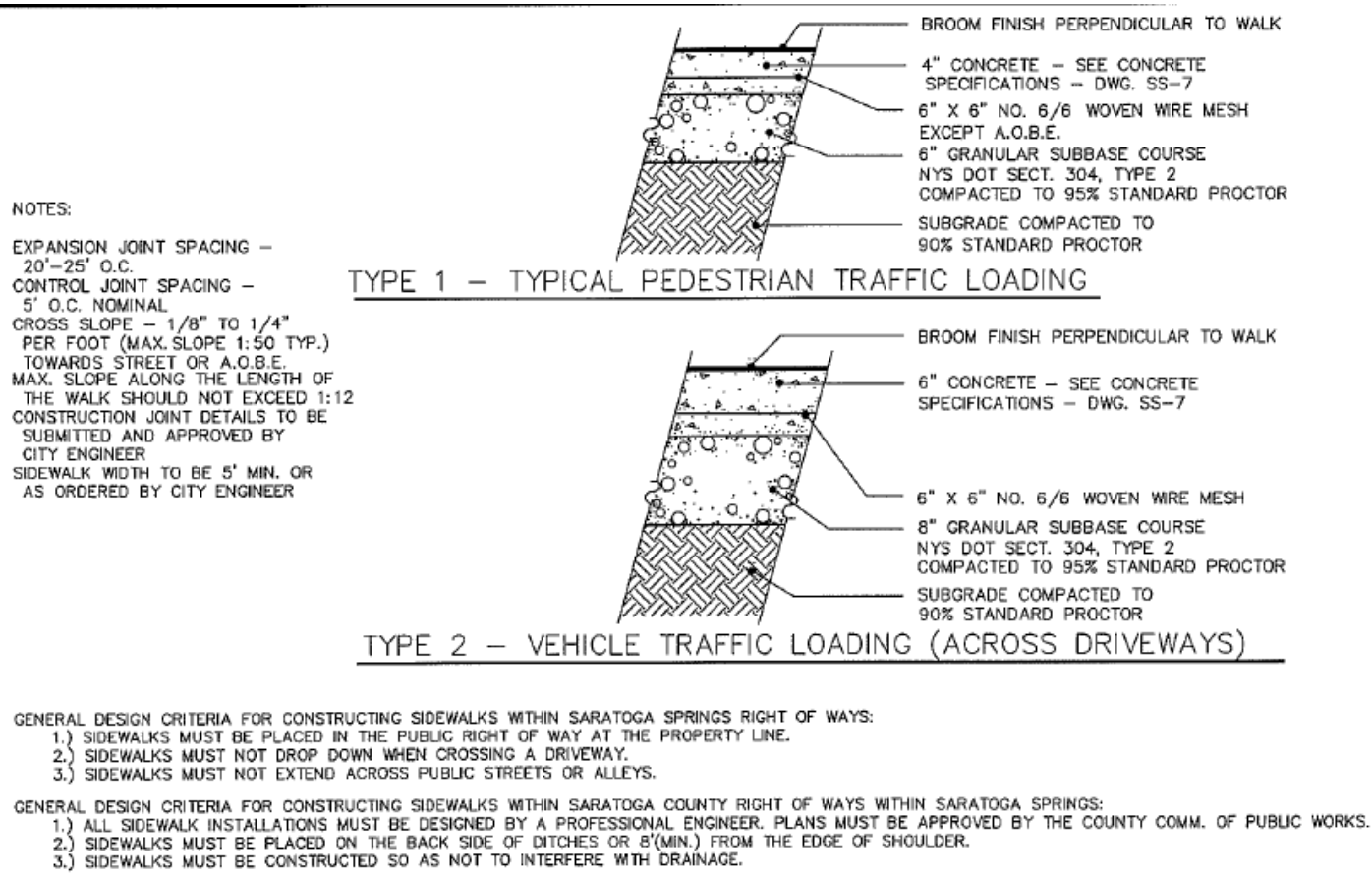

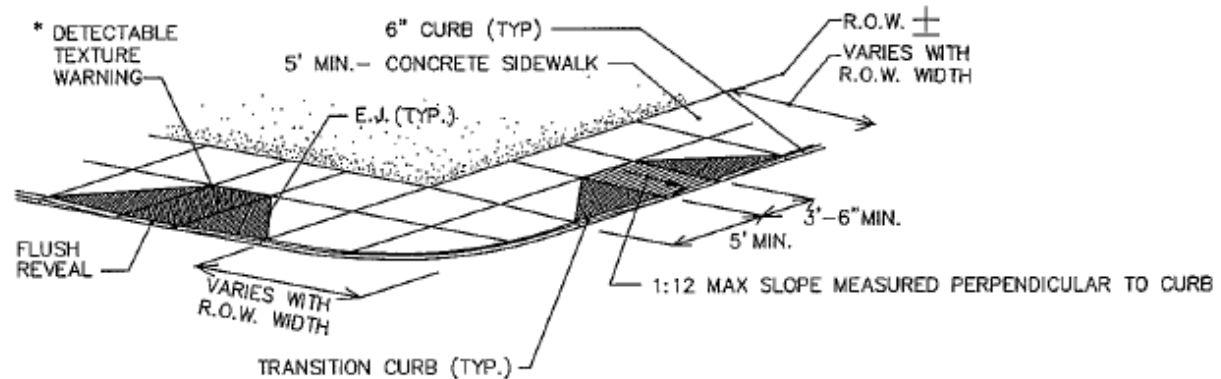

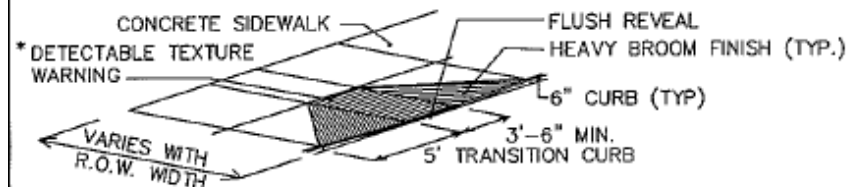




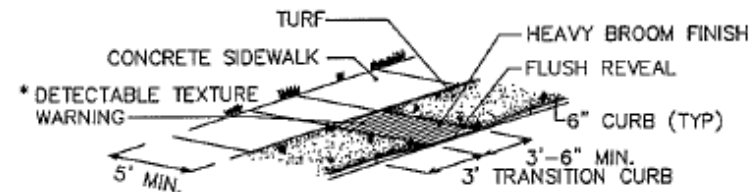

AT SIDEWALK N.T.S.

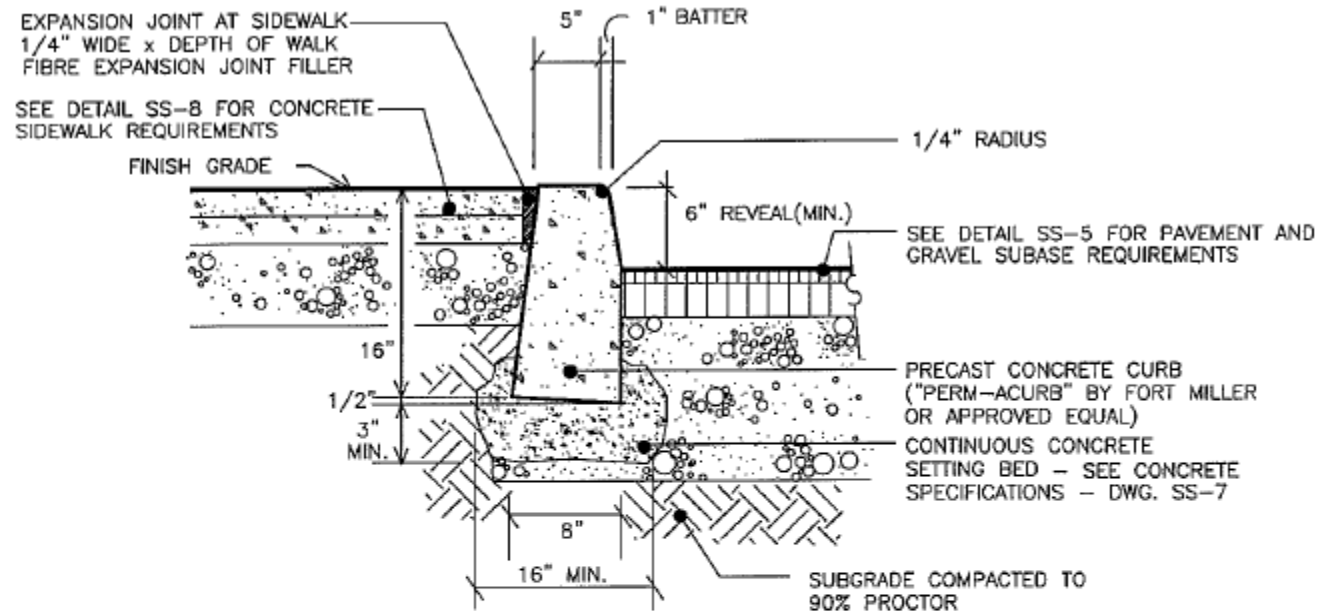


PEDESTRIAN CURB RAMP - TYPE 3
