The Board of Commissioners, Brunswick, Georgia is interested in seeking proposals from interested qualified professionals to provide veterinary services for the Glynn County Animal Control as outlined in the statement of work herein. Proposals will be publicly opened and only the name(s) of those Proposers responding will be mentioned. All Proposers are invited to be present during the proposal opening.

There will be a **non-mandatory Pre-proposal Conference at the Animal Control Building, at 4765 Highway 17 North, Brunswick, GA 31525 on Friday, May 8, 2020 at 3:00 PM (eastern time)**. Any questions and /or misunderstandings that may arise from this invitation shall be submitted, in writing and forwarded, to the Procurement Officer at [vlane@glynncounty-ga.gov](mailto:vlane@glynncounty-ga.gov) no later than **May 15, 2020**. All Questions and Answers submitted will be posted to the website no later than **May 22, 2020**. Answers to questions submitted that materially change the conditions and specifications of this Invitation for Proposal will be promulgated to all addressees as an addendum. Any discussions or documents will be considered non-binding unless incorporated and promulgated in an addendum. It shall be the Proposers responsibility to seek clarification as early as possible prior to the opening of proposals.

Proposals will be received until **May 28, 2020 at 3:00 p.m.** Hand-delivered proposals may be submitted up to 3:00 p.m. on the day of the opening. Proposals will be publicly opened and only the name(s) of those Proposers responding will be mentioned. No proposal may be modified in any way after the deadline for proposal openings.

These instructions are an integral part of any proposal. The Proposers' response shall include the required number of technical proposals and one fee proposal with all other information requested in this Request for Proposal (RFP). Technical response must not have fees listed therein. **If a fee is located in the technical response, the submission will be considered non-responsive and will not be evaluated.** The fees shall be the full cost to the Board of Commissioners, Glynn County, Georgia. **Technical and Fee Proposals must be sealed in separate envelopes with the solicitation name and number and type of Proposal listed on the outside. Failure to do so WILL result in disqualification of the Request for Proposal submission.**

Glynn County anticipates making a single award; however, it reserves the right to make multiple awards should it deem in the best interest of the County. It is anticipated that such an award, if any, will be accomplished within sixty (60) days (unless otherwise agreed upon by the Proposer(s) and the County) from the proposal opening.

Glynn County provides equal opportunity for all businesses and does not discriminate against any person or business because of race, color, religion, sex, national origin, and handicap or veterans status. This policy ensures all segments of the business community have access to supplying the goods and services needed by Glynn County.

**Instruction to Proposers**

1. **Intent:** It is intended that the Instructions to Proposers, General Conditions, and Detailed Specifications shall define and describe the complete work to which they relate.
2. **Work to Be Done:** The work to be performed under this contract consists of, but is not limited to, managing the veterinary care for animals in custody of Animal Control, managing and performing spay/neuter surgery, managing and performing the rabies vaccination program, assisting with cruelty/neglect investigations, training Animal Control staff on best practices in shelter medicine and maintaining Animal Control records according to the SOW detailed herein. The detailed Program Services and Statement of Work begins on Page 18 of this RFP.
3. **Proposal and Contract Security:** None required for this Request for Proposal.
4. **Determination of Successful Proposer:** The Contract will be awarded to the Proposer with the highest score, if awarded.

(a) **Responsibility:** The determination of the Proposer's responsibility will be made by the Owner based on whether the Proposer:

1. Maintains a current Georgia Veterinary License and DEA license,
2. Is USDA accredited to issue health certificates,
3. Has the appropriate technical experience and knowledge to professionally manage best practice-based, compassionate veterinary care in a shelter environment. Related best practices are recommended by the Association of Shelter Veterinarians at <https://www.sheltervet.org>.

The Proposer shall furnish to the Owner all such information and data for this purpose as the Owner may request. The Owner reserves the right to reject any Proposal if the evidence submitted by, or investigation of, the Proposer fails to satisfy the Owner that he is properly qualified to carry out the obligation of the Contract.

(b) **Responsiveness:** The determination of responsiveness will be made by the Owner based on a consideration of whether the Proposer has submitted a complete Proposal form without irregularities, excisions, special conditions, or alternative Proposals for any item unless specifically requested in the Proposal form.

5. **Proposal Alternates:** None are included in this Request for Proposal.
6. **Submission of Proposals:** Proposals shall be submitted at the time and place indicated in the Invitation. Glynn County will not accept late Proposals. Proposers are reminded that documents and information in the possession of Glynn County will be treated as confidential/proprietary information only to the extent permitted by the Georgia Open Records Act, and will be exempt from disclosure to a third party only to the extent permitted by the Georgia Open Records Act. Should you believe that your Proposal contains any trade secrets you must submit an affidavit, along with the Proposal/proposal, that states that specific portions of the Proposal/proposal contain trade secrets as defined by Georgia law (Article 27 of Chapter 1 of Title 10 of the Official Code of Georgia). Furthermore the affidavit must be detailed, citing specifically (citing paragraphs, articles, provisions, pages, etc) the portions of the Proposal/proposal containing any trade secrets.

7. **Proposal Form:** Proposals shall be submitted on the Proposal Forms included. Proposals shall be based upon unit prices for estimated quantities excepting where Proposal items require lump sum proposals as indicated by the Proposal Form. Where errors or omissions result in discrepancies in Proposal totals, prices per unit as submitted will be binding.

Final payment will be based upon actual in-place measured quantities, excepting where lump sums are requested for Proposal items.

8. **Gratuities:** Glynn County acknowledges that, particularly during the holiday season, it may be customary to provide gifts to employees or departments. However, the Glynn County Personnel Policy prevents the acceptance of such gifts. Your cooperation in respecting the policy is appreciated.
9. **Georgia Open Records Act:** Proposers are reminded that documents and information in the possession of Glynn County will be treated as confidential/proprietary information only to the extent permitted by the Georgia Open Records Act, and will be exempt from disclosure to a third party only to the extent permitted by the Georgia Open Records Act. Should you believe that your Proposal contains any trade secrets you must submit an affidavit, along with the Proposal, that states that specific portions of the Proposal contain trade secrets as defined by Georgia law (Article 27 of Chapter 1 of Title 10 of the Official Code of Georgia). Furthermore the affidavit must be detailed, citing specifically (citing paragraphs, articles, provisions, pages, etc.) the portions of the Proposal containing any trade secrets.
10. **Glynn County Local Preference:** This project/solicitation may qualify for local preference in Glynn County, Georgia.

Glynn County shall give Local Preference in the awarding of contracts for sealed solicitations and requests for proposal (hereinafter called "Proposals") whenever the application of such a preference meets the criteria established in the County Ordinance. In order for Local Preference to be used in the evaluation, all documentation as required in the Local Preference Policy must be submitted with the Proposal. This Local Preference privilege shall not apply where prohibited by law.

**Definitions:**

Local Vendor: shall mean that the vendor meets each of the following requirements.

The principal place of business must be with the geographical boundaries of Glynn County, Georgia.

"Principal Place of Business" means a physical structure, office, or suite, but does not include a post office box, a temporary job site, or project location. Further, "Principal Place of Business means that if a vendor is a corporation their corporate office must meet the criteria established above.

Must have a current occupational tax certificate from Glynn County or the City of Brunswick.

Must have paid all real and personal property taxes owed to Glynn County, Georgia.

**Eligibility:**

In order to be eligible for the Local Preference, the vendor must, if incorporated, provide proof from the Georgia Secretary of State that the corporate office is within Glynn County, Georgia. Vendors must provide a copy of their current Glynn County Occupation Tax Certificate, and shall state that all real and personal property taxes due and owing to Glynn County are paid. These items must accompany the Proposal or the vendor will not be subject to award based on Local Preference.

**Application of Local Preference for Sealed Proposals:**

Local vendors complying with the above requirements shall be afforded the opportunity, within a time frame specified by the County, to match the Proposal amount of the lowest responsible, responsive Proposal if: (1) the lowest responsive and responsible Proposer is not a local vendor (2) the local vendor is the second lowest responsive and responsible Proposer; and (3) the local vendor's Proposal is within two (2%) or \$10,000.00 whichever is less, of the lowest Proposal. Local preference shall not apply to Public Works Construction projects of \$100,000 or more nor to public road construction projects of \$20,000.00 or more.

**Application of Local Preference for Requests for Proposal:**

Local vendors complying with the above requirements shall be given two percent (2%) of the total points available within the evaluation criteria.

**Definitions and General Terms and Conditions**  
**Section A**

**Company** - The Proposer

**Contractor** - The successful Proposer(s)

**County** - The Glynn County Board of Commissioners

**Department** - A unit of the Glynn County government that encompasses similar staff functions, purposes, and goals and operates under the direct supervision of the Glynn County Board of Commissioners, a Constitutional Officer or an Appointed Official

**Fee** - A dollar amount inclusive of all Proposer's costs (overhead, insurance, labor, equipment, advertisements, etc.), general & accounting, and profit charged for a specific service(s)

**NTE** - Amount of fee Not to Exceed regardless of the number of transactions ordered

**Principal** - Any officer or director of the proposing organization, and any person, firm, corporation, partnership, joint venture, or other entity, who or which owns or controls three percent (3%) or more of the voting stock or any equivalent voting interest of a partnership or joint venture

**Proposal** - An offer or statement of a price and project description in response to a request for materials or services to be rendered to the County or its employees

**Proposer** - Any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other private legal entity that has submitted a bid which conforms in all material respects to the requirements set forth in the RFP

**Request For Proposal (RFP)** - Executed documents, including documents attached or incorporated by reference, utilized for soliciting proposals in accordance with the RFP procedures and instructions set forth herein

### **1.0 NOTICE OF AWARD (NOA) OF CONTRACT**

As soon as possible, and within 60 days after receipt of Proposals, the County shall notify the successful Proposer(s) of the award of the contract. Should the County require additional time to award a contract, the time may be extended by mutual agreement between the County and the successful Proposer.

If an Award of Contract has not been made within 60 days from the Proposal date or within the extension mutually agreed upon, the Proposer may withdraw the Proposal without further liability on the part of either party.

### **2.0 EXECUTION OF CONTRACT DOCUMENTS:**

- a. Within fifteen (15) days of Notification of Award of Contract, the County shall furnish the Contractor the conformed copies of Contract Documents for execution by him and his Surety.
- b. Within fifteen (15) days after receipt, the Contractor shall return all the documents properly executed by himself and his Surety. Certificates of insurance for the required limits will accompany the Contract documents.

- c. Within thirty (30) days after receipt of the documents executed by the Contractor and certificates of insurance, the County shall complete the execution of the documents. Distribution of the completed documents will be made upon completion.
- d. Should either party require an extension of any of the time limits stated above, this shall be done only by mutual agreement between both parties.

### **3.0 PERFORMANCE AND PAYMENT BONDS**

None required.

### **4.0 INSURANCE:**

The Contractor shall not commence work under this contract until Veterinary Professional Liability Insurance has been obtained and such insurance has been approved by the County, nor shall the Contractor allow any subcontractor to commence work on his subcontract until all similar insurance required of the subcontractor has been so obtained and approved by the Contractor.

#### **A. Liability.**

The Contractor shall maintain Professional Liability insurance as will protect him from claims, which may arise from operations under this contract, whether such operations be by himself or by any sub-contractor or anyone directly or indirectly employed by either of them. Certificates of such insurance shall be filed with the Owner.

#### **B. Indemnity.**

To the fullest extent permitted by laws, statutes, rules and regulations, the Contractor shall indemnify and hold harmless the County, Directors, Employees, Agents, and other Consultants of each and any of them from and against claims, costs, damages, losses, and expenses, including but not limited to all fees and charges of engineers, architects, attorneys and other professionals and all court costs, arising out of or resulting from performance of the work, but only to the extent caused in whole or in part by negligent, reckless, willful and wanton, or wrongful acts or omissions of the Contractor, its Officers, Directors, Employees, Agents, and anyone directly, or indirectly employed by them or anyone for whose acts they may be liable, regardless of whether or not such claim, cost, damage, loss, or expense is caused in part by a party indemnified hereunder, except that no party shall indemnify any other party or person for their own sole negligence.

Such obligation shall not be construed to negate, abridge or reduce other rights or obligations of indemnity which would otherwise exist as to a party or person described in this Paragraph.

#### **\*The limits of insurance are as follows:**

- a) Errors and Omissions or Professional Liability insurance of at least Two Million (2,000,000) Dollars per claim

**\*Professional Liability Insurance shall be effective for the duration of the work as described in the contract documents, including authorized change orders, plus any period of guarantee as required in, Paragraph 4.0 above.**

### **5.0 INDEMNIFICATION:**

The Contractor will indemnify and hold harmless the County and their agents and employees from and against all claims, damages, losses and expenses including attorneys' fees arising out of or resulting from the performance of the work, provided that any such claims, damage, loss or expense is attributable to bodily

injury, sickness, disease or death, or to injury to or destruction of tangible property, including the loss of use resulting therefrom; and is caused in whole or in part by any negligent or willful act or omission of the Contractor, and subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable. In any and all claims against the County or any of their agents or employees, by any employee of the Contractor, any subcontractor, anyone directly or indirectly employed by any of them, or anyone for whose acts any of them may be liable, the indemnification obligation shall not be limited in any way by any limitation on the amount or type of damages, compensation or benefits payable by or for the Contractor or any subcontractor under the Worker's Compensation Acts, Disability Benefits Acts or other employee benefits acts.

#### **6.0 NOTICE TO PROCEED:**

The Notice to Proceed is typically issued within ten (10) days of the execution of the Contract Agreement by the County. However, as stipulated within this RFP, the NTP will only be issued to the Contractor at the onset of disasterous events which demand response activation.

#### **7.0 TERMINATION:**

Termination for Convenience of Owner.

The Owner may, at will, upon written notice to the Contractor, terminate (without prejudice to any right or remedy of the Owner) the whole or any portion of the Work for the convenience of the Owner.

Termination for the Contractor.

The Contractor may terminate any contract arising out of this RFP for any reason upon thirty (30) days written notice to the County. The termination notice shall be deemed received three (3) days after placing the notice in the United States mail.

#### **8.0 ASSIGNMENTS:**

The Contractor shall not assign the whole or any part of this Contract or any monies due or to become due hereunder without written consent of the County. In case the Contractor assigns all or any part of any monies due or to become due under this Contract, the Instrument of assignment shall contain a clause substantially to the effect that is agreed that the right of the assignee in and to any monies due or to become due to the Contractor shall be subject to prior liens of all persons, firms, and corporations for services rendered or materials supplied for the performance of the work called for in this contract.

#### **9.0 SUBCONTRACTING:**

- a. The Contractor shall not subcontract the complete work, or any major part thereof, and shall not award any work to any subcontractor without prior written approval of the County, which approval will not be given except upon the basis of written statements containing such information as the County may require.
- b. The Contractor shall utilize the services of specialty subcontractors on those parts of the work which, under normal contracting practices, are performed by specialty subcontractors. If the Contractor desires to perform specialty work he shall submit a request to the County accompanied by evidence that the Contractor's own organization has successfully performed the work in question, is presently competent to perform the work, and the performance of the work by specialty subcontractors will result in materially increased costs or inordinate delays.
- c. The Contractor shall be as fully responsible to the County for the acts and omissions of his subcontractors, and of persons either directly or indirectly employed by them, as he is for the acts and omissions of persons directly employed by him. The Contractor must ensure payment is made in full to any and all subcontractors.

- d. The Contractor shall cause appropriate provisions to be inserted in all subcontracts relative to the work to bind subcontractors to the Contractor by the terms of the General Conditions and other Contract Documents insofar as applicable to the work of subcontractors and to give the Contractor the same power as regards to terminating any subcontractor that the County may exercise over the Contractor under any provision of the Contract Document.
- e. Nothing contained in this Contract shall create any contractual relation between any subcontractor and the County.

**10. AUTHORITY OF PROJECT MANAGER:**

The Project Manager or his representative shall act as the County's Technical Representative during the execution of this contract. He shall decide questions which may arise as to quality and acceptability of services and products furnished and work performed. He shall interpret the technical intent of the Contract Documents in a fair and unbiased manner. He will make random inspections to determine if the services are proceeding in accordance with the Contracts Documents. He shall judge as to the accuracy of quantities submitted by the Contractor in payment requests and the acceptability of the work which these quantities represent. The decisions of the Project Manager or his representative shall be final and conclusive and binding upon all parties to the Contract.

**11. SEPARATE CONTRACTS:**

- a. The County reserves the right to let other contracts in connection with this project. The Contractor shall afford other Contractors reasonable opportunity for the execution of their work, and the Contractor and other Contractors shall properly connect and coordinate their work with each other.

If the proper execution or results of any part of the Contractor's work depends upon the work of any other Contractor, the Contractor shall inspect and promptly report to the Engineer or his representative any defects in such work that render it unsuitable for such proper execution and results.

- b. The County may perform additional work related to the project with his own forces. The Contractor will afford the County reasonable opportunity for the execution of work, and shall properly connect and coordinate his work with theirs.

**12. LAWS AND REGULATIONS:**

- a. The Contractor's attention is directed to the fact that all applicable Federal, State and County laws, municipal ordinances, and the rules and regulations of all authorities having jurisdiction over the project shall apply to the contract throughout, and they will be deemed to be included in the contract as though written out in full herein. The Contractor shall keep himself fully informed of all laws, ordinances and regulations of the Federal, State, County and municipal governments or authorities in any manner affecting those engaged or employed in the work or the materials used in the work or in any way affecting the conduct of the work and of all orders and decrees of bodies or tribunals having any jurisdiction or authority over same. If any discrepancy or inconsistency should be discovered in these Contract Documents or in the specifications herein referred to, in relation to any such law, ordinance, regulation, order or decree, he shall herewith report the same in writing to the County.
- b. He shall at all times observe and comply with all such existing and future laws, ordinances and regulations, and shall protect and indemnify the County and its agents the violation of any such law, ordinance, regulation, order or decree, whether by himself or by his employees. Permits and licenses of a temporary nature, necessary for the prosecution of the work shall be secured and paid for by the Contractor.

**13. NOTICE AND SERVICE THEREOF:**

- a. All Notices, demands, requests, instructions, approvals, and claims shall be in writing.
- b. Any notice to or demand upon the Contractor shall be sufficiently given if delivered at the office of the Contractor specified in the Proposal (or at such other office as the Contractor may from time to time designate to the County in writing), or if deposited in the United States Mail in a sealed, postage-prepaid envelope, or delivered, with charges prepaid, to any telegraph company for transmission, in each case addressed to such office.
- c. All papers required to be delivered to the County shall, unless otherwise specified in writing to the Contractor, be delivered to the County Procurement Officer, Glynn County, Georgia. Any notice to or demand upon the County shall be sufficiently given if delivered to the Office of said Procurement Officer or if deposited in the United States Mail in a sealed, postage-prepaid envelope, or delivered with charges prepaid to any telegraph company for transmission, in each case addressed to said Procurement Officer or to such other representative of the County or to such other address as the County may subsequently specify in writing to the Contractor for such purposes.
- d. Any such notice or demand shall be deemed to have been given or made as of the time of actual delivery or (in the case of mailing) when the same should have been received in due course of post or (in the case of telegrams) at the time of actual receipt, as the case may be.

**14. SPECIFICATIONS:**

The Special Conditions, Technical Specifications, Statement of Work, Contract Documents, and all supplemental documents, are considered essential parts of the Contract Agreement, and requirements occurring in one are as binding as though occurring in all. They are intended to define, describe and provide for all work necessary to provide the services in an acceptable manner.

**15. CHANGES IN THE CONTRACT:**

- a. **Changes in the Work**. The County may at any time, as the need arises, order changes within the statement of the work without invalidating the Contract Agreement. If such changes increase or decrease the amount due under the Contract Documents, or in the time required for performance of the work, an equitable adjustment shall be negotiated culminate by the issuance of a Contract amendment. The Procurement Officer, also, may at any time, by issuing a Contract amendment, make changes in the details of the work. The Contractor shall proceed with the performance of any changes in the work so ordered by the Procurement Officer unless the Contractor believes that such order entitles him to a change in the fee or time or both, in which event he shall give the Procurement Officer written notice thereof within fifteen (15) days after the receipt of the Contract amendment, and the Contractor shall not execute such amendments pending the receipt of an executed Notice to Proceed instruction from the County.

The County may, when changes are minor or when changes would result in relatively small changes in the Fee or Contract Time, elect to postpone the issuance of a Contract amendment until such time that a single amendment of substantial importance can be issued incorporating several changes. In such cases, the County shall indicate this intent in a written notice to the Contractor.

- b. **Changes in Fee**. The Fee shall be changed only by a mutual agreement by the Contractor and the County transmitted as a Contract amendment. The value of any work covered by an amendment or of any claim for increase or decrease in the Fees shall be determined by one or more of the following methods in the order of precedence according to the following list:
  - 1) By estimating the number of unit quantities of each part of the work which is changed and then multiplying the estimated number of such unit quantities by the fee Proposal for a unit quantity thereof.
  - 2) The County shall fix the total lump sum value of the amendment in the work of the Contractor, and shall set out the price which shall be added to or deducted from the Fees.

The Contractor shall, when required by the County, furnish to the County an itemized breakdown of the quantities and prices used in computing the value of any change that might be ordered.

**16. PAYMENTS AND COMPLETION:**

- a. **Breakdown of Cost.** Before the first application for payment, the Contractor shall submit to the Contract Technical Representative a breakdown of fees for the various portions of the work, including quantities if required by the Administrator, aggregating the total Fee prepared in such form as specified or as the Administrator and the Contractor may agree upon and supported by such data to substantiate its correctness as the Administrator may reasonably require. This schedule, when approved by the Administrator, shall be used only as a basis for the Contractor's application for payment.
- b. **Certificate for Payments.** If the Contractor has made application for payment as above, the Contract Technical Representative will validate the application for such amount as is determined to be properly due, or state in writing the itemized and specific reasons for withholding an application as provided herein. After the Administrator has validated the application for payment, the County shall pay to the Contractor, within thirty (30) days, the amount covering services or work performed or completed. No application for payment, nor any payment, shall constitute an acceptance of any work or service not in accordance with the Contract Documents.
- c. **Failure of Payment.** If the Contract Technical Representative should fail to approve an application for payment, through no fault of the Contractor, within seven (7) days after receipt from the Contractor, or if the County should fail to pay the Contractor within thirty (30) days after receipt of the Contract Technical Representative's approval for Payment, then the Contractor shall receive interest on the balance due with the interest being one percent (1%) per month not to exceed three (3) months (3%). The County reserves the right to reject the Administrator's certification of any application for payment by the Contractor without the accrual of interest.
- d. **Governing Document** All parties expressly agree that the provisions of the Georgia Prompt Pay Act, Title 13, Chapter 11, of the Official Code of Georgia Annotated, are superseded by the terms and conditions of this agreement.

**17. CONTRACTOR'S CLAIM:**

No claim for additional or other compensation beyond the fees shall be allowable unless the Contractor makes and continuously maintains written demand therefor within thirty (30) days of the occurrence of any event which given rise to such claim.

**18. CONTRABAND:**

Employees of the successful Proposer shall not enter County Buildings with goods or products that shall be considered contraband, i.e. drugs, drug paraphernalia, tobacco products smokeless or otherwise, etc.

**19. OFFICE HOURS:**

Normal working hours for the office buildings are Monday through Friday, 8:00 A.M. to 5:00 P.M.

**20. WORK SCHEDULING:**

The successful Proposer shall arrange his work schedule as directed in the Statement of Work and approved by the Contract Technical Representative.

## **21. GEORGIA SECURITY AND IMMIGRATION COMPLIANCE ACT:**

Pursuant to O.C.G.A. § 13-10-91 (Georgia Security and Immigration Compliance Act), every public employer, every contractor of a public employer, and every subcontractor of a public employer's contractor must register and participate in a federal work authorization program. No public employer shall enter into a contract for the physical performance of services within this state unless the contractor registers and participates in a federal work authorization program to verify the work eligibility information of all new employees.

- County. Contractor shall maintain records of such attestation for inspection by Glynn County at any time. The Subcontractor Affidavit shall become a part of the contractor/subcontractor agreement.

## **22. CONTRACT PERIOD:**

It is anticipated that a contract, if awarded, will be for a base period beginning upon receipt of a Notice of Award, which is anticipated to be May 20, 2020 and ending on May 19, 2021, followed by four (4), one (1) year extension options. The County will inform the successful Proposer, in writing, of its intent to execute any further extensions thirty (60) days prior to the end of any contract period then in existence. Notwithstanding the aforementioned, an awarded contract will not be extended beyond the five potential years outlined without being subject to re-bidding.

The Board of Commissioners of Glynn County, Georgia (“the Owner”) seeks proposals from interested qualified professionals to provide Veterinary Services for Glynn County Animal Control as detailed in the Statement of Work within the statement of work of this RFP.

**2.0 BACKGROUND**

Glynn County Animal Control is located at 4765 Highway 17 N Brunswick, GA 31525. It is responsible for the enforcement of state laws and county ordinances relating to the control and protection of domestic dogs and cats and related public safety issues, such as rabies inoculation enforcement, bite investigations, etc, with a full time staff of nine. Animal Control personnel are responsible for:

1. Picking up and receiving stray and vicious dogs and cats. Annually Animal Control has a typical intake of 1,300 animals.
2. Managing care for the animals in custody of approximately 100-130 animals a day.
3. Management of the live release of animals by locating and returning to owners, promoting and re-homing animals, and transferring adoptable animals to other locations for adoption. For example, in 2018, 863 animals had a live release from Animal Control; in 2019, 1,073 animals had a live release.
4. Management of the spay/neuter surgery of adopted animals from Animal Control on a weekly or as needed basis. Animal Control personnel schedules weekly spay/neuter surgery days to comply with Georgia state law that requires pets adopted from shelters to be surgically sterilized.
5. Enforcement of Georgia state law requiring all owned dogs and cats be vaccinated for rabies.
6. Providing microchipping services to pet owners.
7. Providing emergency evacuation sheltering for shelter and owned pets, as well as disaster animal rescue assistance.

**3.0 STATEMENT OF WORK**

I. Veterinary Services:

The successful bidder shall provide Association of Shelter Veterinarians best practice-based, compassionate Veterinary Services for Glynn County Animal Control on site at 4765 Highway 17 North, Brunswick, GA 315. Duties shall include but are not limited to:

1. weekly high-volume spay/neuter surgery of dogs and cats;
2. coordination of the shelter medical program in collaboration with the Division Manager of Glynn County Animal Control;

3. provision of any recommendations for disposition from assessment of temperament and physical condition of animals in writing on Animal Control forms;
4. provision of veterinarian consultation service to staff for the proper care of animals in accordance with best practices as supported by the Associate of Shelter Veterinarians (<https://www.shelternvet.org>);
5. provision of rabies vaccination administrative services;

7. provision of records retention and reporting services; and
8. provision of other veterinary-related services as contingencies arise.

The successful bidder shall render the above veterinary services on site at Glynn County Animal Control sixteen (16) hours per week, broken down into two (2) business days. The successful bidder will also be available for telephone call and text consultations with Animal Control's animal care staff and Manager as appropriate.

The successful bidder shall complete all pending spay and neuter surgeries prior to undertaking any of the other enumerated duties noted herein in the sixteen (16) hours of service. If all spay and neuter services for the week are completed in less than sixteen (16) hours, the successful bidder shall perform his or her other enumerated duties in the remaining allotted time. The successful bidder shall provide additional services, including additional spay and neuter surgeries, beyond sixteen (16) hours per week with prior authorization, in the event those duties cannot be fulfilled in the (16) hours allotted per week.

#### II. High Volume of Spay/Neuter of Dogs and Cats adopted from the Glynn County Animal Control:

The successful bidder shall perform approximately seven (7) to fifteen (15) veterinarian spay or neuter sterilization surgery service for dogs and cats at least two days a week at the Animal Control facility. The weekly schedule shall be determined by mutual agreement with the Animal Control Division Manager. The successful bidder will not need to provide their own technician. Glynn County Animal Control has 3 experienced veterinary technicians and 1 veterinary assistant on staff.

The successful bidder shall identify the method and procedures for the sterilization program to include their methodology or procedures related to:

- a. Pre-surgical physical examinations to determine surgical qualification of an animal;
- b. Administering pre-surgery anesthetics;
- c. Surgical techniques;
- d. Post-operative recovery care and monitoring;
- e. Providing post-operative pain medication;
- f. Animal discharge care/complication instructions as needed;
- g. Post-surgical inquiries and/or complications related to sterilization surgery; and
- h. Controlled drug control, inventory and record keeping.

Glynn County agrees to provide the surgical facility and equipment necessary for the aforementioned spay/neuter services and all necessary disposable medical and surgical supplies. However, the successful bidder shall supply his/her own personal protective surgical clothing, i.e., scrubs, footwear, headwear, etc.

#### III. Rabies Vaccination Program Administration:

The successful bidder shall oversee administration of the rabies vaccination program which shall include, but not limited to, observe quarantined animals as requested by the Manager of Glynn County Animal Control and/or the County Public Health Manager and provide veterinary medical advice.

#### IV. Cruelty/Neglect Investigations Assistance:

The successful bidder shall provide the following support, but not limited to, professional evaluation and advice to Animal Control staff concerning the medical and health conditions of animals suspected to be the object of cruelty or neglect, provide professional testimony in court for criminal or civil litigation when necessary, and interpret

medical records from other veterinarians related to Glynn County investigations. A written assessment of the case shall be provided to the Glynn County Animal Control Manager, or designee, at least 14 days prior to the scheduled court date or at least 48 hours prior to the court date in the event a court date is scheduled such that the Animal Control Manager is unable to provide the case information prior to 14 days before the testimony is required.

V. Shelter's Controlled Drugs:

The successful bidder shall be properly licensed to act as co-signer for the purchase of controlled drugs at the shelter as required by the Drug Enforcement Administration and shall maintain a current license on file with the Glynn County Animal Control. The purpose is to allow Animal Control staff to order, store, and use euthanasia solution and the required drugs for spay/neuter surgery.

VI. Animal Control Staff Training:

The successful bidder shall provide training to the Glynn County Animal Control staff in the areas of animal first aid, neglect, infectious diseases, injury assessment, treatment recommendation and euthanasia procedures, as needed.

VII. Emergency Services:

The successful bidder shall provide emergency telephonic and text veterinary consulting between the hours of 7:00 a.m. and 10:00 p.m., seven days per week, for the Glynn County Animal Control staff regarding the health of impounded animals.

VIII. Veterinarian of Record for Supply Distributors:

The successful bidder agrees to be the Veterinarian of Record for the purpose of ordering medical supplies for the shelter by animal control personnel. Ordering is done by the Division Manager.

IX. Permits/Licenses:

The successful bidder shall be the Veterinarian of Record for the purpose of maintaining a current Veterinary Premise license with the State of Georgia and the a DEA Permit/Registration. A copy of the veterinarian's current state license and the DEA Permit/Registration shall be posted at the Glynn County Animal Control.

X. Professional Liason:

The successful bidder shall act as the professional liaison with the Glynn County veterinary community.

XII. Records:

The successful bidder shall work with Animal Control's Lead Veterinary Technician and the Manager to maintain records on the number of dogs and cats spayed or neutered or any other treatments, sufficiently detailed to enable Glynn County to verify services performed and provide accurate statistics to potential funders.

XIII. Health Certificates:

The successful bidder shall maintain any needed accreditation with the USDA in order to provide health certificates for shelter animals being transported out of the state of Georgia.

Note: While the evaluation team will review the proposal in its entirety and may consider anything that they find relevant, particular emphasis is placed on the following:

### 4.0 COST PROPOSAL

Each Proposer is required to submit a cost proposal as part of its response. The cost proposal will be evaluated and scored in accordance with scoring criteria. By submitting a response, the supplier agrees that it has read, understood, and will submit a Proposal by the following instructions/rules:

The draft contract format will be the **only** acceptable document for execution. **Glynn County will not entertain or accept any exceptions or amendments to the contract format provided.**

**Part A: Contract Form**

ARTICLE 1. The Contractor agrees to provide all the staff, facilities, materials, equipment and labor necessary to carry out, in good faith, the complete requirements of the project specified as **Veterinary Services for Glynn County Animal Control - Rebid**, in strict conformity with all sections of Solicitation RFP #01166, hereinafter set forth, whose program services together with the Contractor's Proposal, the Advertisement for Proposals, Instructions to Proposers, General Conditions, Representations, this Agreement, and all addenda hereto annexed, shall form essential parts of this Agreement as if fully contained herein.

**Part F**  
**Statement of Work**

**I. VETERINARY SERVICES:**

The successful bidder shall provide veterinary services for Glynn County Animal Control on site at 4765 Highway 17 North, Brunswick, GA 315. Duties shall include, but are not limited to:

1. Picking up and receiving stray and vicious dogs and cats. Annually Animal Control has a typical intake of 1,500 animals;
2. Managing care for the animals in custody of approximately 100-130 animals a day.
3. Management of the live release of animals by locating and returning to owners, promoting and re-homing animals, and transferring adoptable animals to other locations for adoption. For example, in 2018, 863 animals had a live release from Animal Control; in 2019, 1,073 animals had a live release.
4. Management of the spay/neuter surgery of adopted animals from Animal Control on a weekly or as needed basis. Animal Control personnel schedules weekly spay/neuter surgery days to comply with Georgia state law that requires pets adopted from shelters to be surgically sterilized.
5. Enforcement of Georgia state law requiring all owned dogs and cats be vaccinated for rabies.
6. Providing microchipping services to pet owners.
7. Providing emergency evacuation sheltering for shelter and owned pets, as well as disaster animal rescue assistance.

The successful bidder shall render the above veterinary services on site at Glynn County Animal Control sixteen (16) hours per week. The sixteen (16) hours of service shall be submitted as a flat-rate bid, identified as the base price in the Requestor's response schedule. Services rendered that exceed the sixteen (16) hours per week shall be submitted as "extra hourly fees" in the Requestor's response schedule.

**II. HIGH VOLUME OF SPAY/NEUTER OF DOGS AND CATS ADOPTED FROM GLYNN COUNTY ANIMAL CONTROL:**

The successful bidder shall perform approximately seven (7) to fifteen (15) veterinarian spay or neuter sterilization surgery service for dogs and cats at least two days a week at the Animal Control. The weekly or as needed schedule shall be determined by mutual agreement with Animal Control staff. The successful bidder agrees to provide a surgical assistant at their expense.

The successful bidder shall identify the method and procedures for the sterilization program to include their methodology or procedures related to:

- a. Pre-surgical physical examinations to determine surgical qualification of an animal
- b. Administering pre-surgery anesthetics
- c. Surgical techniques
- d. Post-operative recovery care and monitoring
- e. Providing post-operative pain medication
- f. Animal discharge care/complication instructions as needed
- g. Post-surgical inquiries and/or complications related to sterilization surgery; and
- h. Controlled drug control, inventory and record keeping

Glynn County agrees to provide the surgical facility and equipment necessary for the aforementioned spay/neuter services and all necessary disposable medical and surgical supplies. However, the successful bidder shall supply own personal protective surgical clothing, i.e., scrubs, footwear, headwear, etc.

### **III. RABIES VACCINATION PROGRAM ADMINISTRATION:**

The successful bidder shall oversee administration of the rabies vaccination program which shall include, but not limited to, observe quarantined animals as requested by the Manager of Glynn County Animal Control and/or the County Public Health Manager and provide veterinarian medical advice.

### **IV. CRUELTY/NEGLECT INVESTIGATIONS ASSISTANCE:**

The successful bidder shall provide the following support, but not limited to, professional evaluation and advice to Animal Control staff concerning the medical and health conditions of animals suspected to be the object of cruelty or neglect, provide professional testimony in court for criminal or civil litigation, when necessary and interpret medical records from other veterinarians related to Glynn County investigations. A written assessment of the case shall be provided to the Glynn County Animal Control Manager, or designee, at least 14 days prior to the scheduled court date or at least 48 hours prior to the court date in the event a court date is scheduled such that the Animal Control Manager is unable to provide the case information prior to 14 days before the testimony is required.

### **V. SHELTER'S CONTROLLED DRUGS:**

The successful bidder shall be properly licensed to act as co-signer for the purchase of controlled drugs at the shelter as required by the Drug Enforcement Administration and shall maintain a current license on file with the Glynn County Animal Control. The purpose is to allow Animal Control staff to order, store, and use of euthanasia solution, and the required drugs for spay/neuter surgery.

### **VI. EMERGENCY SERVICES:**

The successful bidder shall provide emergency telephonic veterinary consulting between the hours of 7:00 a.m. and 10:00 p.m., seven days per week, for the Glynn County Animal Control staff regarding the health of impounded animals.

### **VII. VETERINARIAN OF RECORD FOR SUPPLY DISTRIBUTORS:**

The successful bidder agrees to be the Veterinarian of Record for the purpose of ordering medical supplies for the shelter by animal control personnel.

### **VIII. PERMITS/LICENSES:**

The successful bidder shall be the Veterinarian of Record for the purpose of maintaining a current Veterinary Premise license with the State of Georgia and the a DEA Permit/Registration. A copy of the veterinarian's current state license and the DEA Permit/Registration shall be posted at the Glynn County Animal Control.

### **IX. PROFESSIONAL LIASON:**

The successful bidder shall act as the professional liaison with the Glynn County veterinary community.

### **XIII. RECORDS:**

The successful bidder shall work with Animal Control's Lead Veterinary Technician and the Manager to maintain records on the number of dogs and cats spayed or neutered or any other treatments, sufficiently detailed to enable Glynn County to verify services performed and provide accurate statistics to potential funders.

**XIII. HEALTH CERTIFICATES:**

The successful bidder shall maintain accreditation with the USDA in order to provide health certificates for shelter animals being transported out of the I. Veterinary Services:
