**FIFTH PLAN SUPPLEMENT FOR SECOND AMENDED
JOINT PREPACKAGED CHAPTER 11 PLAN OF REORGANIZATION OF
RUBIO’S RESTAURANTS, INC. AND ITS DEBTOR AFFILIATES PURSUANT
TO CHAPTER 11 OF THE BANKRUPTCY CODE, DATED DECEMEBER 14, 2020**

Rubio’s Restaurants, Inc. and its affiliated debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “Debtors”) submit this plan supplement (this “Plan Supplement”) in support of, and in accordance with, the *Second Amended Joint Prepackaged Chapter 11 Plan of Reorganization of Rubio’s Restaurants, Inc. and its Debtor Affiliates Pursuant To Chapter 11 Of The Bankruptcy Code*, dated December 14, 2020 [Docket No. 278] (as may be amended, supplemented, or modified from time to time, the “Plan”). ***This Plan Supplement amends the fourth Plan Supplement filed on December 21, 2020 [Docket No. 299] solely with respect to the amendment and restatement of the Assumed Executory Contracts and Unexpired Leases Schedule.*** Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Plan. The documents contained in this Plan Supplement are integral to, part of, and incorporated by reference into the Plan. These documents have not yet been approved by the Bankruptcy Court. If the Plan is confirmed by the Bankruptcy Court, the

EXHIBIT F**REVISED Assumed Executory Contracts and Unexpired Leases Schedule**

IMPORTANT NOTE: The Debtors reserve the right through the occurrence of the Effective Date to (i) remove any agreement from the Assumed Executory Contracts and Unexpired Leases Schedule, (ii) add any agreement to the Assumed Executory Contracts and Unexpired Leases Schedule, or (iii) revise any Cure Costs.

Section 5.1(a) of the Plan provides: “All Executory Contracts and Unexpired Leases of the Debtors that are not otherwise assumed or rejected will be deemed rejected by the applicable Debtor or Reorganized Debtor in accordance with the provisions and requirements of sections 365 and 1123 of the Bankruptcy Code, other than (i) those that are identified on the Assumed Executory Contracts and Unexpired Leases Schedule; (ii) those that have been previously assumed or rejected pursuant to a Final Order by the Debtors prior to the Effective Date; and (iii) those that are the subject of a motion seeking assumption or rejection as of the Effective Date. Each Executory Contract and Unexpired Lease assumed pursuant to this Article V but not assigned to a third party shall be deemed to be assigned to a Reorganized Debtor, and be fully enforceable by, the applicable contracting Reorganized Debtor(s) in accordance with the terms thereof, except as otherwise modified by the provisions of the Plan, or by any order of the Bankruptcy Court.”

The tables below sets forth the executory contracts and unexpired leases that the Debtors may assume under section 5.1 of the Plan, along with the corresponding Cure Costs, to the extent such agreements (i) have not previously been assumed or rejected by the Debtors in the Chapter 11 Cases, (ii) have not previously expired or terminated pursuant to their own terms, and (iii) are not the subject of a separate motion to assume or reject such agreements filed by the Debtors under section 365 of the Bankruptcy Code prior to the Effective Date. To the extent that the Debtors have entered into or do enter into any amendment or modification of any of the executory contracts and unexpired leases being assumed under section 5.1 of the Plan in connection with, or prior to, the assumption of such executory contract and unexpired lease, such agreement will be assumed as amended or modified.

On November 23, 2020, the Debtors filed a notice identifying all agreements that are **potentially** subject to assumption (and assignment, as applicable) under the Plan. *See* Docket No. 189 (the “Cure Notice”). As set forth in that notice, any party to an agreement with the Debtors that is the subject of potential assumption (and assignment, as applicable) that does not consent to the assumption (and assignment, as applicable) of their applicable agreement or objects to the proposed Cure Cost set by the Debtors must file an objection with the Court within 14 days of the date of that notice (*i.e.*, by December 7, 2020) or the Court may deem them to consent to the assumption (and assignment, as applicable) of their agreement and the applicable Cure Costs. ***This is the case even if the agreement is not currently listed on the Assumed Executory Contracts and Unexpired Leases Schedule.***

Nothing herein shall be construed as a concession or evidence that any of the contracts identified herein constitute an “executory contract” within the meaning of 11 U.S.C. § 365 and other applicable law, nor that any of the leases identified herein have not expired, been terminated or are otherwise currently in full force and effect. Rather, the Debtors expressly reserve all of their

rights with respect thereto, including their right to seek a later determination of these issues and their right to dispute the validity, status, characterization or enforceability of any contracts, agreements or leases set forth herein. Certain of these contracts, agreements and leases may have been modified, amended or supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letters and other documents, instruments and agreements that may not be listed herein, but are nonetheless incorporated herein by this reference.

The Assumed Executory Contracts and Unexpired Leases Schedule is subject to ongoing review, revision, and modification and the Assumed Executory Contracts and Unexpired Leases Schedule may be amended, modified or revised as permitted by the Plan or any order of the Bankruptcy Court.

1. Items marked with an asterisk (“*”) in the Note Column below reflect adjustments to the Cure Cost since filing the Cure Notice that **have been agreed** to with the affected counterparty or resulting from payment of the Cure Costs under the Critical Vendor program.
2. Items marked with a dagger (“†”) in the Note Column are contracts for which the Debtors and the counterparty are in active discussions to resolve Cure Cost amounts.
3. Items with a Sequence Numbers of 1012 or higher were not originally included on the Cure Notice, and the Debtors intend to provide supplemental notice of their intent to assume these agreements and the applicable Cure Costs.
