Leadership Development Definition:


An intentional, individualized effort to grow the ability of all student pharmacists to lead positive change with or without a title, delivered in a manner that encourages students' active engagement in leadership.

Leadership Competencies:

- Competency 1: Explain the importance of leadership in pharmacy.
- Competency 2: Recognize that leadership comes from those with and without titles.
- Competency 3: Distinguish between leadership and management.
- Competency 4: Describe the characteristics, behaviors and practices of effective leaders.
- Competency 5: Demonstrate self-awareness in leadership.
- Competency 6: Engage in personal leadership development.
- Competency 7: Develop a shared vision for an initiative or project.
- Competency 8: Collaborate with others.
- Competency 9: Lead members of a team
- Competency 10: Develop knowledge of organization culture.
- Competency 11: Outline change processes.

P1 Year

PHRM 862: "Institutional Pharmacy IPPE"- Students contribute to practice site to improve patient outcomes

PHRM 869: "Practice Management and Marketing"- development of a business plan to address societal need

PHRM 870: "Health Policy Applications" – Debate project requires students to consider stakeholder viewpoints on a particular issue, develop a logical argument, and persuasively articulate a position to advance practice

PHRM 878: "IPE"- IPLA #5 teamwork participation within an interdisciplinary team in the community/society

PHRM 880: "APPE" Reflections about individual leadership experiences at the end of clerkship rotations (add to APE or rotation evaluation)

Group Values: Emphasis on collaboration and interaction between group and the individual
