Technology Use & Liability Agreement

I, ("Parent"), understand and accept the following conditions and responsibilities related to my child's ("Student" ("s")) use of a computer, iPad, and/or other technology issued by the Temecula Valley Unified School District ("District"):

1. The District is providing a computer, iPad, and/or other technology ("District Technology") to Student, at no cost, to facilitate distance learning and to enable Student to access his/her educational program. All District Technology, including, but not limited to, all accessories, apparatus, cases, and/or equipment that is provided with District Technology are the sole property of the District.
2. District Technology shall be used solely by Student. Student shall use District Technology in a safe and responsible manner, and only for educational purposes. Student shall not use District Technology to engage in non-school related activities.
3. Student shall not use District Technology to encourage the use of drugs, alcohol, tobacco, or any other illegal substances.
4. Student shall not use District Technology to harass, intimidate, harm, disparage, bully, or threaten other students, staff, or other individuals, or to access, post, or display harmful or inappropriate matter that promotes any activity prohibited by law, District Board Policies, and/or District Administrative Regulations.
5. Student shall not damage, destroy, modify, or abuse District Technology hardware or software in any way.
6. Student shall not change any computer settings or install programs on District Technology without permission from a teacher and/or other District representative.
7. Student and Parent shall report any dangerous, inappropriate, or offensive content received, or security problems Student encounters while using District Technology.
8. Student shall keep personal account numbers and passwords private. Unless otherwise instructed by school personnel, Student shall not disclose, use, or disseminate personal identification information related to him/her or others when using email, chat rooms, or other forms of electronic communication.
9. Student shall have no expectation of privacy in District Technology. The District reserves the right to monitor, collect, and/or inspect District Technology for improper use without advance notice to, or consent from, Student and/or Parent.
10. I have received, reviewed, and understand the District's policies related to Student Use of Technology, as described in Board Policy ("BP") 6163.4 and Administrative Regulation ("AR") 6163.4. Student and I will

comply with BP 6163.4 and AR 6163.4 at all times.

11. In the event Student uses District Technology in a manner that is inconsistent with this Agreement or in a manner that violates District rules, regulations, or policies, the District may cancel and/or limit Student's user privileges or increase supervision of Student's use of District Technology, as the District deems appropriate. Inappropriate use of District Technology may also result in disciplinary action and/or legal action in accordance with the law and District policies and regulations.
12. Student and Parent shall be responsible for the reasonable cost of repair or replacement of District Technology or other related equipment that is damaged or lost while in Student's possession, whether on or off school property, as a result of Student's misuse, abuse, or negligence.
13. In accordance with BP 6163.4 and AR 6163.4, before Student is authorized to use District Technology, Student and Parent shall sign and return the District's Acceptable Use Agreement, which is enclosed as Exhibit A.

By signing this Agreement, I acknowledge that I have read, reviewed, and understand the terms of the Agreement and that I have reviewed with Student the District's rules, regulations, and policies related to Student's use of District Technology, as outlined in the Agreement and BP 6163.4 and AR 6163.4.
