NOTIFICATION

The following draft of amendment to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules 1975, which it is proposed to make in exercise of powers conferred by section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970) is hereby published for information of all the persons likely to be affected thereby, as required by sub-section (1) of section 35 of the said Act.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of forty-five days from the date of publication of this Notification in the Tamil Nadu Government Gazette and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of aforesaid period will be considered by the Government of Tamil Nadu. The objection and suggestion, if any, should be addressed to the Principal Secretary to Government of Tamil Nadu, Labour and Employment Department, Fort.St.George, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006.

DRAFT NOTIFICATION

In the said Rules, in rule 82, the following proviso shall be added to sub-rule (2) namely:-

" Provided that no annual return in Form XXV need be sent by the Principal Employer of a registered establishment, if a combined annual return in Form No.22as required in clause (2) of rules 100 of the Tamil Nadu Factories Rules, 1950 is furnished. "
