

CONTRACT EXTENSION AGREEMENT

This CONTRACT EXTENSION AGREEMENT is made as of the 11th Day of March, 2020 by and between the BROOKFIELD BOARD OF EDUCATION, of Brookfield Connecticut with a central office located at 100 Pocono Road, Brookfield, Connecticut, hereinafter referred to as the "Board", and ALL-STAR TRANSPORTATION, a Connecticut corporation with an office and place of business located at 146 Huntingdon Avenue, Waterbury, Connecticut, hereinafter referred to as the "Contractor" (hereinafter sometimes collectively referred to as the "Parties").

WITNESSETH:

WHEREAS, the Board has been duly empowered by Section 10-220 of the Connecticut General Statutes to enter into a contract for the transportation of school children; and

WHEREAS, the Board and the Contractor entered into a Contract (the "Original Contract") covering the period from July 1, 2015 through June 30, 2020; and

WHEREAS, by unanimous vote of all members present at a regular meeting of the Board held on February 19, 2020, the Board voted to waive bidding requirements consistent with the provisions of Board Policy 3320.1, Subsection IV and furthermore to enter into a CONTRACT EXTENSION AGREEMENT with the Contractor for the purpose of providing transportation for school children residing in the Town of Brookfield for the period commencing July 1, 2020 and terminating on June 30, 2022; and

NOW THEREFORE, in consideration of the mutual covenants contained herein, the Parties hereby mutually agree as follows:

1. The Original Contract, which is attached hereto and incorporated herein in its entirety as a part of this Contract Extension Agreement, will end on June 30, 2020.
2. The Parties agree to extend the original contract for an additional period, which will begin immediately upon the expiration of the Original Contract and will expire on June 30, 2022.
3. This Contract Extension Agreement binds and benefits the Parties hereto. This document, including the attached Original Contract, constitutes the entire agreement between the parties.
4. All other terms and conditions of the Original Contract remain unchanged, with the following exceptions:
 - a. Subsection 2.a [first sentence] shall be changed to read as follows: "The bell schedule for Brookfield's four (4) schools for the 2020-21 and 2021-22 school years shall be as follows:"
 - b. The Appendix A shall be changed to read as follows:


- c. The Memorandum of Understanding addressing diesel fuel costs for busses used in the summer of each school year for non-Board purposes executed and dated May 19, 2015 by the Contractor and May 13, 2015 for the Board shall be considered a part of the "Original Contract".






