PURPOSE

The Woodlands Convention & Visitors Bureau (TWCVB or CVB) is seeking proposals to provide exclusive catering and catering management services which may include catering, event set up, reservations, and guest satisfaction on the Waterway Cruisers on The Woodlands (Texas) Waterway. The CATERER/RESTAURANT must meet the minimum standards outlined in the attached proposal. The Woodlands CVB owns six (6) Waterway Cruisers and these vessels are operated by the Brazos Transit District. The Woodlands Township is the primary funder of The Woodlands Convention & Visitors Bureau and is listed in this RFP.

Contract length is one year with one year of first right of refusal. Contract time frame is expected for April 1, 2011 through March 31, 2012.

The Woodlands CVB is looking for qualified and established CATERER/RESTAURANT who will be able to handle the following:

- Catered events on the Waterway Cruisers
- Handle reservations of catered events on the Waterway Cruisers
- Provide marketing expertise to promote such services
- Excel in Guest Satisfaction
- Secure and maintain proper license(s), insurance and legal documents
- Perform superior accounting practices

The Woodlands CVB reserves the right to reject any or all proposals, waive any informalities, award the contract to other than the highest bidder if, in the evaluations committee's opinion, such action would ensure service of better quality. The Woodlands CVB shall also have the ability to negotiate minor deviations to the proposal with the successful proprietor. The Woodlands CVB Board of Directors decision shall be final and binding.

GENERAL

Objective:

The objective of awarding catering privileges on the Waterway Cruisers is to provide individuals, groups and entities the highest level of service, food quality and experience. The Woodlands CVB seeks a CATERER/RESTAURANT who will be able to handle reservations, market events using the boats, has proper permits through the Texas Alcohol Beverage Commission (TABC), is creative in nature, and fully embraces the tourism appeal of The Woodlands for meetings, conventions, special events including weddings and reunions and general leisure travel.

BACKGROUND

The Woodlands Convention & Visitors Bureau owns six (6) boats called Waterway Cruisers. The six (6) boats are scheduled to undergo renovations in the beginning of 2011. These 35-foot boats travel along a 1.5 mile long Waterway in the heart of the commercial district in The Woodlands, Texas. Each trip from end to end takes approximately 20 to 40 minutes, depending on number of stops and the preference of the event scheduled. Without tables, each boat can seat up to 40 passengers. Two boats are outfitted with tables, seating 20 individuals.

Only three (3) Waterway Cruisers can be catered at one time. The other three (3) boats need to be available or public transportation.

For each event, catering supplies must be loaded and unloaded at the Waterway Cruiser dock pending all necessary approvals. If the CATERER's/RESTAURANT's place of business is located on The Woodlands Waterway, they may load at their dock if approved. During Charters, riders will have access to the public restrooms at Waterway Square.

REQUIREMENTS

IDEMNIFICATION - HOLD HARMLESS. CATERER hereby agrees to indemnify and defend at its own cost, and to hold The Woodlands Convention & Visitors Bureau, The Woodlands Township and their elected and appointed boards, officers, directors, agents, subsidiaries and employees, as well as those with whom The Woodlands Township and/or The Woodlands Convention & Visitors Bureau have contracted for and have procured rights from related to operating the Waterway Cruisers, including but not limited to The Woodlands Development Company, LP and the Brazos Transit District (collectively the "Township and CVB Persons") harmless from any and all actions, claims, demands, liabilities, losses, damage, and personal injury, including death; as well as from claims for property damage, cost or expense of whatever kind in connection therewith, brought or presented by any person, firm, employees, or agents of CATERER and their dependents and personal representative arising from any act or omission of CATERER, its agents, servants, employees or any subcontractor's operations under this Agreement or incidental to any of the work, or the conditions of the work on or about The Woodlands Waterway, whether such operations be by CATERER or any subcontractors, or by any one or more persons directly or indirectly employed by, or acting as agent for, CATERER or any subcontractor, and irrespective of whether any Township and CVB Persons were concurrently negligent with CATERER and irrespective of the negligence of any of the Township or CVB Persons', if any, whether active or passive. The indemnity provided for in this paragraph shall have no application to any claim, liability, or cause of action resulting from the sole negligence of Township or CVB Persons.

INSURANCE. CATERER, agrees to maintain and require its subcontractors to maintain at all times the following coverage's at no less that the limits indicated:

CATERER's/RESTAURANT's coverage must be written on an Occurrence (not claims made) basis with companies acceptable to CVB and Township, must stipulate that no take-out endorsements are included on the General Liability policy, and each policy providing coverage hereunder shall contain provisions that no cancellation or material reduction in coverage in the policy shall become effective except upon thirty (30) days prior written notice thereof. The Woodlands Convention & Visitors Bureau, The Woodlands Township, The Woodlands Development Company and Brazos Transit District shall be named as additional insured with respect to liability imposed upon it resulting from the performance of Work under this Agreement. There shall be no right of subrogation against TWCVB and the Township and this waiver of subrogation shall be endorsed upon the policies prior to the commencement of performance of the Work,

CATERER/RESTAURANT shall furnish certificates (which shall identify CVB and Township and this Agreement) to TWCVB and The Woodlands Township in duplicate, evidencing compliance with all requirements herein. The limits of such insurance shall in no way be construed as limiting the CATERER's/RESTAURANT's obligation to completely defend, indemnify and hold harmless The Woodlands Convention & Visitors Bureau and The Woodlands Township.

Independent Contractor Status:

The CATERER/RESTAURANT and its employees will not be employees of The Woodlands CVB or The Woodlands Township and are not eligible for any benefits through The Woodlands Township, including without limitation federal social security, health benefits, workers' compensation, unemployment compensation, and retirement benefits.

The CATERER/RESTAURANT is engaged as an independent contractor and will be responsible for any federal, state, and local taxes and fees applicable to CATERER's/RESTAURANT's activities.

Fire Safety:

CATERER's/RESTAURANT's equipment using any fuel systems are required to obtain any and all necessary permits before use under the terms of the CATERING contract. Permits must be on file at the The Woodlands CVB and The Woodlands Township's office before operation

Licenses, Fees, and Compliance with Laws and Regulations

The CATERER/RESTAURANT shall obtain all necessary licenses and permits and pay all fees required to operate such concession and shall comply with all federal, state, and local laws and regulations applicable to such operation, including approvals with the Texas Alcohol Beverage Commission (TABC).

CONDITIONS OF OPERATION

1. CATERER/RESTAURANT shall provide and manage full reservation system -- from sales, order collection, payment and fulfillment.
2. CATERER/RESTAURANT accepts full and complete responsibility for any and all loss of or damage to any item of the CATERER's/RESTAURANT's and the Township's property from any cause whatsoever and expressly releases The Woodlands CVB and The Woodlands Townships, its officers, agents, directors, and, employees, from any liability therefore.
3. The CATERER's/RESTAURANT's contract or privilege therein provided may not be assigned or transferred. Failure to comply with this provision will result in termination of the contract.
4. The CATERER/RESTAURANT shall provide, as part of the bid, any subcontractors that may work with the CATERER/RESTAURANT on the Waterway Cruisers.
5. CATERER/RESTAURANT shall provide refuse containers suitable for litter generated by customers or other persons. CATERER/RESTAURANT shall be responsible for removing all refuse and waste generated by CATERER's/RESTAURANT's operation. All such litter, refuse, and waste shall be removed from the area for proper disposal at CATERER's/RESTAURANT's expense. CVB shall charge for the costs of special cleanup (\$25 per staff hour + 15% administrative charge) necessary should the CATERER/RESTAURANT fail to reasonably perform.
6. The Woodlands CVB and The Woodlands Township shall be under no obligation to furnish equipment, furniture, or fixtures.
7. Improvements to the boats shall not be made without the approval of The Woodlands CVB President and shall be made at the CATERER's/RESTAURANT's expense. Such improvements shall be in compliance with all local, federal, state, and local laws and regulations. Such improvements, unless designated temporary, shall become property of The Woodlands CVB.
8. CATERER/RESTAURANT shall be permitted to sell and distribute alcoholic beverages under the privileges provided herein provided service is in compliance with all federal, state, and local laws.
9. CATERER/RESTAURANT shall eliminate any unsafe condition or public hazard resulting from or associated with CATERER's/RESTAURANT's activities without delay as directed by the President of The Woodlands CVB.
10. CATERER/RESTAURANT shall provide a menu with prices that would be planned on being provided to potential customers. Menus and prices, when updated, shall be provided to The Woodlands CVB.
11. Notwithstanding the conditions of operation included herein, the CATERER/RESTAURANT shall abide by all rules and regulations of The Woodlands Township.
12. Events of The Woodlands CVB, The Woodlands Township, The Woodlands Development Company, the owner of The Woodlands Waterway, and Brazos Transit District, transportation operators of The Woodlands Waterway, are excluded from this proposal.

RIGHTS RESERVED

1. The Woodlands CVB reserves the right to reject any and/or all proposals in whole or in part.
2. In the event that CATERER/RESTAURANT fails to comply with any of the requirements or conditions of the contract, which is based upon and includes these specifications, The Woodlands CVB reserves the right to suspend or terminate immediately the contract by mailing written notice of the breach to CATERER/RESTAURANT, addressed to CATERER's/RESTAURANT's last address on file with The Woodlands CVB.
3. If the CATERER/RESTAURANT voluntarily terminates the contract, or if The Woodlands CVB for any cause terminates the contract, CATERER/RESTAURANT shall forfeit all amounts paid to The Woodlands CVB.
4. The Woodlands CVB reserves the right to:
 - a. To terminate a CATERING contract or portion thereof should the service prove unsatisfactory in the opinion of the CVB Board of Directors.
 - b. To review for approval all items and services offered and all prices of items and services provided to the public.
 - c. To change the minimum bid amount without notice any time prior to the acceptance of a bid proposal.

INSTRUCTION TO BIDDERS

Proposals:

Proposals on the approved form provided must be enclosed with bid in a sealed envelope and mailed or delivered to Julie DeGuerre, Event Specialist of The Woodlands Convention & Visitors Bureau, 10001 Woodloch Forest Drive, Suite 600, The Woodlands, Texas 77380. The outside of the envelope shall plainly identify: 1) The Subject of the Bid and 2) The Bidder's Name.

All proposals must be clearly and distinctly typed or written with ink or indelible pencil. No erasures are permitted. Mistakes must be crossed out and corrections typewritten or written in ink adjacent thereto, and initialed in ink by the party signing the bid, or the party's authorized representative.

All applicable blanks on the approved form must be filled in and the bid signed by the bidder or the bidder's representative. Any statement accompanying and tending to qualify a bid may cause rejection of such bid.

Basis of Award:

The Woodlands CVB will make awards to each responsible/responsive bidder submitting the most advantageous bid to The Woodlands CVB and to the CATERER/RESTAURANT who can provide full reservations capacity, marketing of such services and full guest satisfaction experience. The Woodlands CVB reserves the right to reject any or all bids in whole or in part, or waive irregularities not affecting substantial rights.

Judging for the winning bidder will be based on the following criteria (See Appendix A for a more complete description):

- **Marketing Plan – 30%**
- **Customer Service and Reservation Management – 40%**
- **Menu – 30%**



COMMENCEMENT OF WORK
