TFP Contract Make Up Artist/Hair Stylist Release Form

This document constitutes a binding contract between _____
(hereafter "Make Up Artist/Hair Stylist"), and **Thomas H.P. Jerusalem [of A-MOMENT-IN-TIME.COM Photography]** (hereafter "Photographer"), regulating the ownership and use of photographs and derivative works based thereupon (collectively hereafter the "Photos") taken by Photographer of Model _____ on the date of _____ for all lawful purposes, subject to the terms and conditions described below.

The basis for this contract is a non-commercial arrangement where Make Up Artist/Hair Stylist in the interest of gaining experience or enhance their portfolio, agrees that in exchange of time, he/she shall receive processed photographs delivered to Make Up Artist/Hair Stylist by Photographer in the quantity and format described as follows: **digital images shot on the date mentioned above**. Delivery shall take place in a timely manner and under any circumstance no

longer than 30 days after the date this contract is signed by Photographer. This delivery constitutes the whole obligation of Photographer towards Make Up Artist/Hair Stylist. However the

Make Up Artist/Hair Stylist agrees that copyright, moral rights, and all other intellectual property rights to the Photos belongs to Photographer and/or his or her heirs, licensees or assigns, with full right of lawful disposition in any manner.

Make Up Artist/Hair Stylist agrees that, while he/she may use the Photos for purposes related to the promotion of Make Up Artist/Hair Stylist's business, including, but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, Make Up Artist/Hair Stylist will not sell or otherwise transfer publication rights to any of the Photos without Photographer's prior consent.

Make Up Artist/Hair Stylist understands that Photographer has the moral right to be identified as the author of the Photos when copies of the Photos are presented to the public, and shall communicate this understanding to publishers, designers and other third parties that act on Make Up Artist/Hair Stylist's behalf to create presentation material using the Photos. Photo credit will be given at all times to: ***A-MOMENT-IN-TIME.COM Photography.***

Make Up Artist/Hair Stylist agrees that the Photos shall not be altered or distorted in any way when they are used to promote Make Up Artist/Hair Stylist's business. Any watermark and copyright notice that appear as part of a Photo must be left intact.

Under no circumstances should Photos be sold by Make Up Artist/Hair Stylist unless price and compensation is agreed under a signed contract with Photographer.

Make Up Artist/Hair Stylist releases and agrees to hold Photographer and/or his or her heirs, licensees or assigns, harmless from any claim or liability in connection with the publication or use of these images in any manner or form whatsoever, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting Make Up Artist/Hair Stylist to conspicuous ridicule, scandal, reproach, scorn, and indignity.

Make Up Artist/Hair Stylist hereby affirms that his/her date of birth is _____ and that Make Up Artist/Hair Stylist is fully able to contract in his/her own name without breach of any prior agreement or applicable law, including, but not limited to, prior agreements with agencies etc.

Images will be provided in digital format optimized for web, and – on request, free of charge – in high-resolution format optimized for print.

Make Up Artist/Hair Stylist understands that Photographer or anybody in the team cannot be made responsible for damage, dirt, loss etc of accessories, props provided by Make Up Artist/Hair Stylist unless the act has been provoked.

Both Make Up Artist/Hair Stylist and Photographer affirms to have read the foregoing prior to its execution and agree to the contents thereof.
