

TEAM AGREEMENT FOR USE OF THE GYM AT OLD CHAMBLEE MIDDLE SCHOOL

The DeKalb County School System has graciously allowed us to use this gym. Please remember that any misuse of this property may jeopardize everyone's access to this facility. For that reason, you and your players must respect this property and the hospitality of the School System at all times.

1. Payment for your use of this facility will be in advance. You are expected to honor your time commitments at all times. In other words, if you agreed to use the facility from 7:00 pm to 9:00 pm, then you are expected to have someone at the facility at 7:00 pm so that it can be opened up and turned over to your team. You cannot decide at the last minute that you will not use the facility and not show up. When your team's time period has expired, then you are expected to leave the facility and turn it over to the next team scheduled to use the facility or, if you are the last team that day, turn off the lights and lock up. Please do not make another team waiting to use the facility ask you to relinquish the facility.

2. A parent or guardian for each player using this facility must sign the Player's Hold Harmless Agreement. You are expected to obtain a copy of this Agreement from all players prior to their use of the facility. Please provide the original executed Agreement to Scott Farrow and keep a copy of the Agreement for your files.

3. Cleanup – you are expected to leave the facility as you found it. All trash should be picked up and placed in receptacles. Please check and clean up the restrooms before you leave. Do not allow your players to eat sunflower seeds or similar products that will create a mess. If your team leaves a mess, then you will be fined \$50.00.

4. If your team or coaches damage the facility, then you will pay the cost for repairs or replacements. If you discover damage to the facility caused by someone else, please report it immediately to Scott Farrow so we can better determine who caused the damage.

5. You are responsible for supervising your players at all times. They cannot be in this facility without a coach or parent present at all times to supervise them. Horseplay or injuries caused by a lack of supervision will not be tolerated.

6. No alcohol or tobacco products are allowed on the premises.

7. Absolutely no cleats are allowed in this facility. Please let your players know in advance about this rule and explain to them that they will have to practice without shoes if they wear cleats.

8. You are expected to consider the safety of your players as paramount and supervise them accordingly. Catchers are expected to use appropriate safety equipment when catching pitchers. All batters must wear helmets unless: (a) hitting off a tee; or (b) hitting soft toss. The team will have at least one coach for every 5 players. No more than 12 players will be participating in practice at one time.

Please help make this a safe facility that we can all enjoy for years to come.

The undersigned further represents that they have adequate insurance in place to cover the cost of any injury or damage to person or property sustained by Player while using the Facility and that they understand that Releasees have relied upon this representation as a condition to entry to the Facility.
