



## PHOTOGRAPHY/VIDEO AGREEMENT & RELEASE (ADULTS & MINORS)

In consideration of the engagement of \_\_\_\_\_ ("Actor") by Rollins College (as hereinafter defined) as a model/actor, and for other good and valuable consideration herein acknowledged as received, I on behalf of myself, or if the Actor is a minor, on behalf of my minor child, grant to Rollins College on a perpetual, irrevocable and unrestricted basis the right to use, re-use, publish and re-publish photographic portraits or pictures and/or video tape footage of the Actor, including the Actor's face and/or image ( the "Actor's Likeness"), in which the Actor may be included in whole or in part, whether as a composite or distorted in character or form, and whether in conjunction with the Actor's own name or a fictitious name. The right granted herein to use the Actor's Likeness shall not extend to any reproductions thereof in color or otherwise, made through any medium and in any and all media now or hereafter known whether employed singularly or in conjunction with printed and/or other accompanying material and whether employed for illustration, promotion, art, editorial, advertising, trade or any other purposes whatsoever, including commercial purposes, and regardless of the manner in which said use is transmitted (e.g., television programming, internet, printed page, [e.g., magazine, brochure, book], motion picture, etc.).

The Actor waives any right to inspect or approve the finished product or products and/or the advertising copy or other material containing the Actor's Likeness that may be employed in connection with the grant described above. The Actor further waives any right to compensation received by Rollins College in association with the commercialization of the Actor's Likeness, including the sale of said Likeness in one or more "stock pictures."

The Actor releases and agrees to hold harmless the College, its employees, officers and agents, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or in use in composite form, whether intentional or otherwise, that may occur or be produced in the capturing and/or processing of the Actor's Likeness, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.

For purposes of this grant, the term "Rollins College" shall include all business entities which are now or in the future owned or controlled by Rollins College and those business entities which are or subsequently become subject to the common control or ownership of an organization of an organization which controls or owns Rollins College.

I hereby warrant that I am over the age of 18 and have the right to contract in my name, or on behalf of the Actor, if the Actor is a minor or child. I have read the content of this document prior to its execution, and I am fully familiar with the contents thereof. This release shall be binding upon the Actor, his heirs, legal representatives and assigns, and the individual (including the individual's heirs, legal representatives and assigns) executing this document in those circumstances where the Actor is a minor child.
