

Patrol

During the month of November, officers of the Operations Division worked a total of 3,714.5 hours. 60.5 work hours were completed by Non-Probationary Reserve Officers not in the FTO program.

**Total hours reflect actual road hours (training and meeting hours are excluded).



Enforcement Highlights

On November 1, 2021, Officer David Shedrow initiated a traffic stop for an infraction. Upon making contact and identifying the driver, Officer Shedrow observed inconsistencies in the drivers story. Officer Shedrow also observed the driver to be making movements within the vehicle as if the driver were trying to hide something. Officer Shedrow deployed his police K9 around the vehicle. The K9 showed a positive indication of narcotics in the vehicle. A search revealed drug paraphernalia and possible stolen tools. The driver has been charged for the possession of paraphernalia.

On November 1, 2021, Officer Kaleb Goodpaster responded to a report of threats on Jefferson Street. Upon arrival, Officer Goodpaster spoke with the reporter who said that the suspect made threats and was possibly impaired. The reporter further said that they want the suspect trespassed from their residence. Nearly 30 minutes after the call for service, Officer Goodpaster located the suspect driving on East Main Street and initiated a traffic stop for an infraction. While speaking with the suspect, Officer Goodpaster smelled the odor of alcohol about the driver. The driver admitted to consuming alcohol hours before. Officer Goodpaster administered field sobriety tests to the driver. The driver failed all tests and consented to a certified breath test. The driver was transported to the Brownsburg Police Department but could not provide adequate breath samples. The driver was then transported to a medical facility where a blood draw was completed. The driver was charged and transported to jail.

On November 1, 2021, Officer Dimitry Kalyuzhny initiated a traffic stop on a suspected impaired driver. Upon making contact with and identifying the driver, Officer Kalyuzhny observed signs of impairment. Officer Kalyuzhny requested the driver to exit the vehicle to perform field sobriety tests. The driver failed the first test and could not complete the remainder of testing. The driver consented to a certified test in the form of a blood draw. The driver was transported to a medical facility where the blood draw was completed. The driver was charged and transported to jail.

On November 2, 2021, Officer Heather Foote initiated a traffic stop for an infraction. Upon making contact with the driver and other occupants, the driver could not provide identification and provided Officer Foot fictitious personal information. Officer Foote also detected the odor of marijuana in the drivers vehicle. Investigation revealed that the driver had an active warrant out of Montgomery County. A search of the vehicle revealed suspected marijuana, methamphetamine, and drug paraphernalia. The driver was charged and transported to jail.

On November 3, 2021, Officer David Koelling responded to a report of theft from a vehicle on Windhaven Circle. The victim reported that a wallet was stolen from the vehicle during the overnight hours of November 2, 2021. It was reported that the vehicle was left unsecured. A second report completed where a wallet was taken from another vehicle. This vehicle was left unsecured as well. Cash, credit cards and identification were taken in both thefts. No suspect information was provided at the time of the reports.

On November 4, 2021, Officer Kaleb Goodpaster initiated a traffic stop for multiple infractions. Upon making contact and identifying the driver, registration could not be provided for verification. There were also inconsistencies to the drivers story. Officer Goodpaster requested assistance from a police K9. An Avon Police Officer arrived and deployed his police K9 around the vehicle. The K9 alerted to the presence of narcotics in the vehicle. A search revealed suspected methamphetamine. Further investigation revealed that a passenger had an active warrant in Marion County. The driver was charged and both driver and passenger were transported to jail.

On November 5, 2021, Cpl. Chris Nelson responded to a report of an impaired driver at Main and Green Street. Cpl. Nelson located the vehicle and began to follow. Cpl. Nelson observed several violations associated with impaired driving and initiated a traffic stop. Upon making contact with the driver, Cpl. Nelson detected the odor of alcohol emanating from the vehicle and observed alcohol containers in the vehicle. The driver admitted to consuming alcohol prior to being stopped. Cpl. Nelson requested the driver to exit and administered field sobriety tests. The driver failed all tests and consented to a certified breath tests. The driver was transported to the Brownsburg Police Department for testing. The driver was unable to provide breath samples and was transported to a medical facility for a blood draw. Upon completion of the draw, the driver was charged and transported to jail.

On November 7, 2021, Cpl. Chris Nelson initiated a traffic stop for multiple infractions. Upon making contact with the driver, Cpl. Nelson observed signs of impairment and smelled the odor of alcohol emanating from the vehicle. The driver denied consuming alcohol and was asked to exit the vehicle for field sobriety testing. The driver failed all testing and consented to a certified breath test. The driver was transported to the Brownsburg Police Department for testing and provided an insufficient breath sample. A warrant for a blood draw was obtained and the driver was transported to a medical facility for a blood draw. Upon completion of the draw, the driver was charged and transported to jail.

On November 11, 2021, Officer Nick Pugliese initiated a traffic stop for an infraction. Upon making contact with the driver, Officer Pugliese smelled the odor of marijuana emanating from the vehicle. Officer Pugliese also observed indicators of illegal drug activity inside the vehicle. Officer Pugliese requested a police K9 to assist with the stop. A Plainfield Police Officer arrived with his K9 partner and deployed the K9 around the vehicle. The K9 gave positive indication of narcotics inside the vehicle. A search revealed 30 pounds of suspected marijuana in the trunk of the vehicle. The driver was charged and transported to jail.

On November 15, 2021, there was a report of an impaired person at a fuel station in Pittsboro. The subject entered a vehicle and began to drive east on Interstate 74. Officer Kaleb Goodpaster located the vehicle and initiated a traffic stop after observing an infraction. Upon identifying the driver, Officer Goodpaster observed signs of impairment displayed by the driver. Officer Goodpaster requested the driver to exit the vehicle and administered field sobriety tests. The driver failed all tests and initially consented to a certified breath test. The driver was transported to the Brownsburg Police Department and the driver refused to submit to a certified breath test. Officer Goodpaster requested and obtained a search warrant for a blood draw. The driver was transported to a medical facility where a blood draw was completed. Upon completion, the driver was charged and transported to jail.

On November 16, 2021, there was a report of theft from a vehicle on Derby Way. The victim reported a firearm was taken from a vehicle during the overnight hours on November 15, 2021. It was reported that the vehicle was left unsecured. There was also a vehicle that was stolen from the same area on the same date that was recovered in Indianapolis. It was reported that the keys were left in the vehicle.

On November 20, 2021, Officer Dimitry Kalyuzhny assisted an off duty detective with a traffic stop on a suspected impaired driver on Interstate 74. It was reported that the vehicle was all over the roadway prior to the stop. While speaking with the driver, Officer Kalyuzhny could smell the odor of alcohol about the driver and observed signs of impairment. Officer Kalyuzhny transported the driver to an alternate location for field sobriety testing due to roadway traffic. The driver failed the first test and could not complete remaining tests. The driver consented to a certified breath test. The result of the test was three times the legal limit. The driver was charged and transported to jail.

On November 20, 2021, Officer Heather Foote initiated a traffic stop on a suspected impaired driver. Upon making contact with the driver, Officer Foote observed signs of impairment and empty alcohol containers in the vehicle. Officer Foote requested the driver to exit the vehicle to perform field sobriety tests. The driver failed the first test and could not complete the remaining tests. The driver consented to a certified breath test and was transported to the Brownsburg Police Department. The result of the test was nearly three times the legal limit. The driver was charged and transported to jail.

On November 21, 2021, Officer Heather Foote initiated a traffic stop on a suspected impaired driver. Upon making contact with the driver and passenger, it appeared that both subjects were impaired. Officer Foote requested the driver to exit the vehicle to perform field sobriety tests. The driver failed all tests and consented to a certified breath test. The driver then became uncooperative and would not comply with police commands. The driver was restrained and placed in a police vehicle and transported to the Brownsburg Police Department where a warrant was obtained for a blood draw. The driver was transported to a medical facility where the blood draw was completed. Upon completion of the draw, the driver was charged and transported to jail. Due to disorderly conduct and intoxication, the passenger was charged and transported to jail.

On November 25, 2021, Officer Nick Pugliese initiated a traffic stop on a suspected impaired driver. Upon making contact and identifying the driver, Officer Pugliese detected the odor of alcohol emanating from the interior of the vehicle. The driver also showed signs of impairment. Officer Pugliese requested the driver to exit the vehicle to perform field sobriety tests. The driver failed one of three tests and could not complete the remaining tests. The driver refused a certified breath. Officer Pugliese obtained a search warrant for a blood draw and transported the driver to a medical facility for the draw. Upon completion of the blood draw, the driver was charged and transported to jail.

On November 25, 2021, Officer Eustace Mlagan responded to a report of a possible impaired driver in the area of U.S. 136 and County Road 1000 East. Officer Mlagan located the vehicle in the area of Main Street and East Northfield Drive. Officer Mlagan observed infractions associated with impaired driving and initiated a traffic stop. Upon making contact with the driver, Officer Mlagan observed signs of impairment and detected the odor of alcohol about the driver. The driver was transported to an alternate location for field sobriety testing due to weather conditions. The driver failed all testing and consented to a certified test in the form of a blood draw. The driver was transported to a medical facility where the blood draw was completed. Upon completion, the driver was charged and transported to jail.

On November 27, Officer Aaron Smith assisted Sgt. Doug Abshire on a traffic stop involving a suspected impaired driver. Upon making contact with the driver, officers observed signs of impairment and open containers in the vehicle. Officer Smith requested the driver to exit the vehicle to perform field sobriety tests. The driver failed the first test and could not complete the remaining tests due to impairment. The driver consented to a certified breath test and was transported to the Brownsburg Police Department for testing. The result of the test was nearly twice the legal limit. The driver was charged and transported to jail.

On November 27, 2021, Officer Elsiana Crosby responded to a no injury crash at 56th Street and County Road 900 East. While conducting the investigation, Officer Crosby detected the odor of alcohol about one of the drivers. Officer Crosby also observed an open container in the vehicle of the driver. Officer Crosby administered field sobriety tests to the driver. The driver failed the first test and could not complete the remainder of testing. The driver was transported the Brownsburg Police Department where a warrant was obtained for a blood draw. Upon completion of the blood draw, the driver was charged and transported to jail.

On November 28, 2021, Officer Elsiana Crosby initiated a traffic stop for an infraction. Upon making contact with the driver, Officer Crosby detected the odor of alcohol coming from the driver. Officer Crosby also observed signs of impairment about the driver and the driver admitted to consuming alcohol. Officer Crosby administered field sobriety tests to the driver. The driver failed all testing and consented to a certified breath test. The driver was transported to the Brownsburg Police Department for testing. The driver could not provide sufficient samples and was transported to a medical facility for a blood draw. Upon completion of the blood draw the driver was charged and transported to jail.

Reserve Officer Aaron Smith is accelerating through phase 2 and is receiving very favorable evaluations during his training. Officer Smith is getting very good exposure to different calls for service that other officers in field training might not see on a regular basis. Officer Smith is very close to completion of phase 2.

Use of Force

The Brownsburg Police Department documented eight Use of Force Reports during the month of November. The reports are documented as follows: Weaponless Physical, Firearm Pointing and Other (K9).

Documented report 1 involved a Brownsburg Officer deploying on a “high risk” traffic stop on a wanted subject. The officer pointed his department issued firearm at the vehicle and ordered the subject out of the vehicle. The subject complied with officer commands and was taken into custody without incident.

Documented report 2-4 involved Brownsburg Officers initiating a traffic stop resulting in a vehicle pursuit. As the vehicle came to rest, officers deployed on a “high risk” stop pointing their department issued firearms at the vehicle. The driver complied with officer commands and was taken into custody without incident.

Documented report 5-7 involved Brownsburg Officers assisting on a vehicle pursuit initiated by a neighboring agency. As the vehicle came to rest, officers deployed on a “high risk” stop pointing their department issued firearms at the vehicle. Officers gave loud commands to the driver in which the driver would not comply with officer commands. The driver continued to make movements inside the vehicle. A Brownsburg Officer deployed his police K9 and was able to make apprehension on the driver; however, the driver continued to resist. The driver was then taken into custody and sustained minor injuries.

Documented report 8 involved a Brownsburg Officer initiating a traffic stop. The vehicle did not stop and continued traveling on the roadway. The vehicle eventually stopped and the driver jumped out of the vehicle yelling at the officer. Due to the rapidly evolving circumstances, the officer pointed his department issued firearm at the subject. The subject was taken into custody without further incident.

Vehicle Pursuit

The Brownsburg Police Department documented six Vehicle Pursuit Reports during the month of November.

Documented report 1 involved a Brownsburg Officer initiating a traffic stop. Upon activating emergency lighting, the suspect vehicle accelerated at a high rate of speed passing vehicle in a no passing zone. The vehicle turned north on East Northfield Drive continuing to disregard the pursuing police vehicle. The Brownsburg Officer lost sight of the suspect vehicle and terminated the pursuit. Shortly after termination of the pursuit, a witness contacted the Hendricks Communications Center to inform them of the location of the suspect. Brownsburg Officers located the vehicle in the area where the pursuit was terminated and took the suspect into custody without incident. Pursuit distance was 3 miles lasting 3 minutes.

Documented report 2 involved a Brownsburg Officer assisting a neighboring agency on a traffic stop where the agency officer was going to search the vehicle. The suspect that had been stopped, ran to his vehicle and fled the scene of the stop at a high rate of speed. Officers pursued the vehicle which east on U.S. 36. During the pursuit, the driver of the vehicle turned the headlights off making it difficult to see where the vehicle was going. Officers eventually lost sight of the vehicle and the pursuit was terminated. Pursuit distance was 10 miles lasting 5 minutes.

Documented report 3 involved a Brownsburg Officer initiating a traffic stop on Interstate 74. Upon activating emergency lighting, the suspect vehicle accelerated at a high rate of speed. The suspect vehicle fled west on Interstate 74 and exited at State Road 267 then entered the eastbound travel lane of Interstate 74. An assisting agency successfully deployed a tire deflation device and the vehicle eventually stopped on the interstate. The suspect was taken into custody without further incident. Pursuit distance was 10 miles lasting 9 minutes.

Documented report 4 involved a Brownsburg Officer assisting with a pursuit initiated by a neighboring agency. The pursuit continued north on Ronald Reagan Parkway into Brownsburg jurisdiction where the Brownsburg Officer assisted. A Brownsburg Officer successfully deployed a tire deflation device and the vehicle eventually stopped. The suspect was taken into custody without incident. Pursuit distance was 3 miles lasting 10 minutes.

Documented report 5 involved a Brownsburg Officer assisting with a pursuit initiated by a neighboring agency. The pursuit entered Brownsburg jurisdiction on Ronald Reagan Parkway where the Brownsburg Officer assisted. The pursuit went east on 56th Street to Raceway Road and then south on Raceway Road. The pursuit ended at Raceway Road and 42nd Street where the suspect was taken into custody. Pursuit distance was 10 miles lasting 10 minutes.

Documented report 6 involved a Brownsburg Officer initiating a traffic stop on Wild Ridge Boulevard. The Brownsburg Officer activated his emergency lighting and the suspect vehicle continued north on Wild Ridge to River Ridge Drive. The suspect vehicle then turned on Barbara Drive and came to a stop. The driver was taken into custody without further incident. Pursuit distance was 1 mile lasting 1 minute.

Traffic

During the month of November, the Traffic Unit received zero workflow complaints. The Traffic Unit continues enforcement from workflows received throughout the year.

Officer Dan Rooker has received final approval from Indiana Criminal Justice Institute (ICJI) on grant funded yearlong traffic enforcement. The first traffic blitz will run from December 15, 2021 to January 1, 2022, will focus on seat belts and impaired driving. The second blitz will begin on December 17, 2021 and end on January 1, 2022 and will solely focus on impaired driving. Citizens will see an increased police presence throughout the town in addition to normal police patrols.

The Traffic Unit assisted Brownsburg Community School Corporation with a study of ingress/egress traffic in specific parking areas of the school. The speed trailer was placed in areas to capture data needed for the study. A report has been provided to Chief Ginnie Wing for this specific study.

Narcotics

On November 29, 2021, Brownsburg Narcotics Unit (BNU) Officers, assisted the Indianapolis DEA Office in executing a knock and talk on a house in Indianapolis. Officers and Agents conducted a search of the residence and discovered approximately 10 kilos of cocaine and a significant amount of U.S. Currency.

November was primarily used as a month to work on finishing up ongoing cases for the year along with working towards the closure of a major ongoing case. In addition, BNU officers were down one officer due to injury and all other officers have been utilizing vacation time prior to years end.

Emergency Response Team

The Brownsburg Emergency Response Team (ERT) conducted two trainings during November. Training dates occurred on November 23rd and November 30th.

Training on November 23rd took place at the Brownsburg Police Training Facility beginning with some classroom instruction. The team transitioned to the indoor range for firearms qualification and weapon transition drills. The team then transitioned to the training house and completed small room/hallway clearing drills. Training ended with a team building exercise.

Training on November 30th began at the Brownsburg Police Training facility with classroom instructional videos. The team transitioned to the training house for continued repetition of basic room entry and hallway clearing. The team then relocated to Parkside Bible Church for large structure clearing for the remainder of the training.

Reserves

Reserve Officers provided in excess of 60 hours of road coverage during the month of November. Cpl. Rob Van and Officer Chad Brandon were officers that provided shift coverage with short notice.

Cpl. Rob Van responded to a citizen who had been locked out of their car. This resulted in a felony traffic arrest.

Sgt. Kim Kiritschenko and Officer Kevin Hyde continue to prepare for the annual Christmas event hosted by FORD. Eleven children have been confirmed to attend to date.
